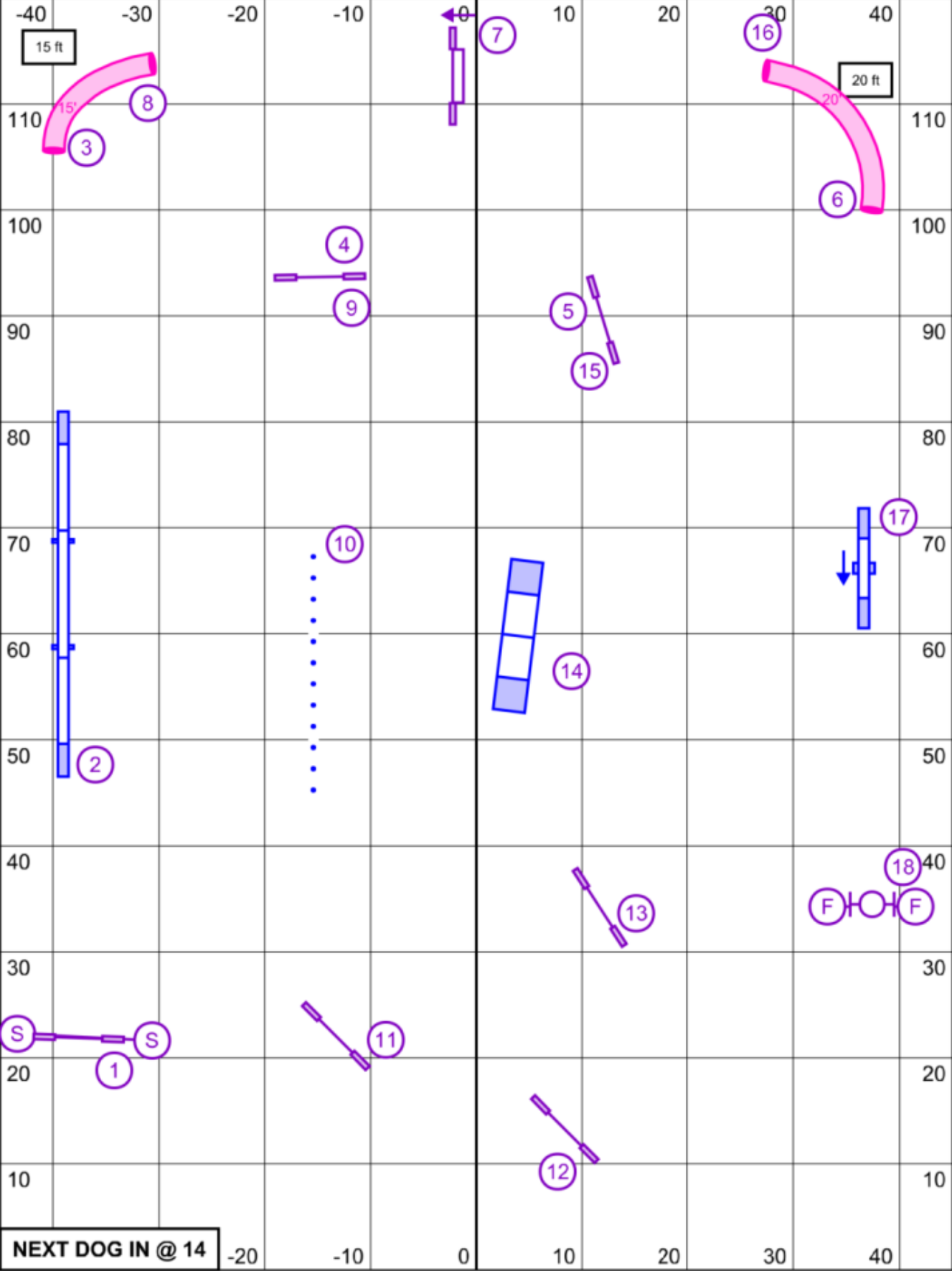

Joker worth 20 pts.

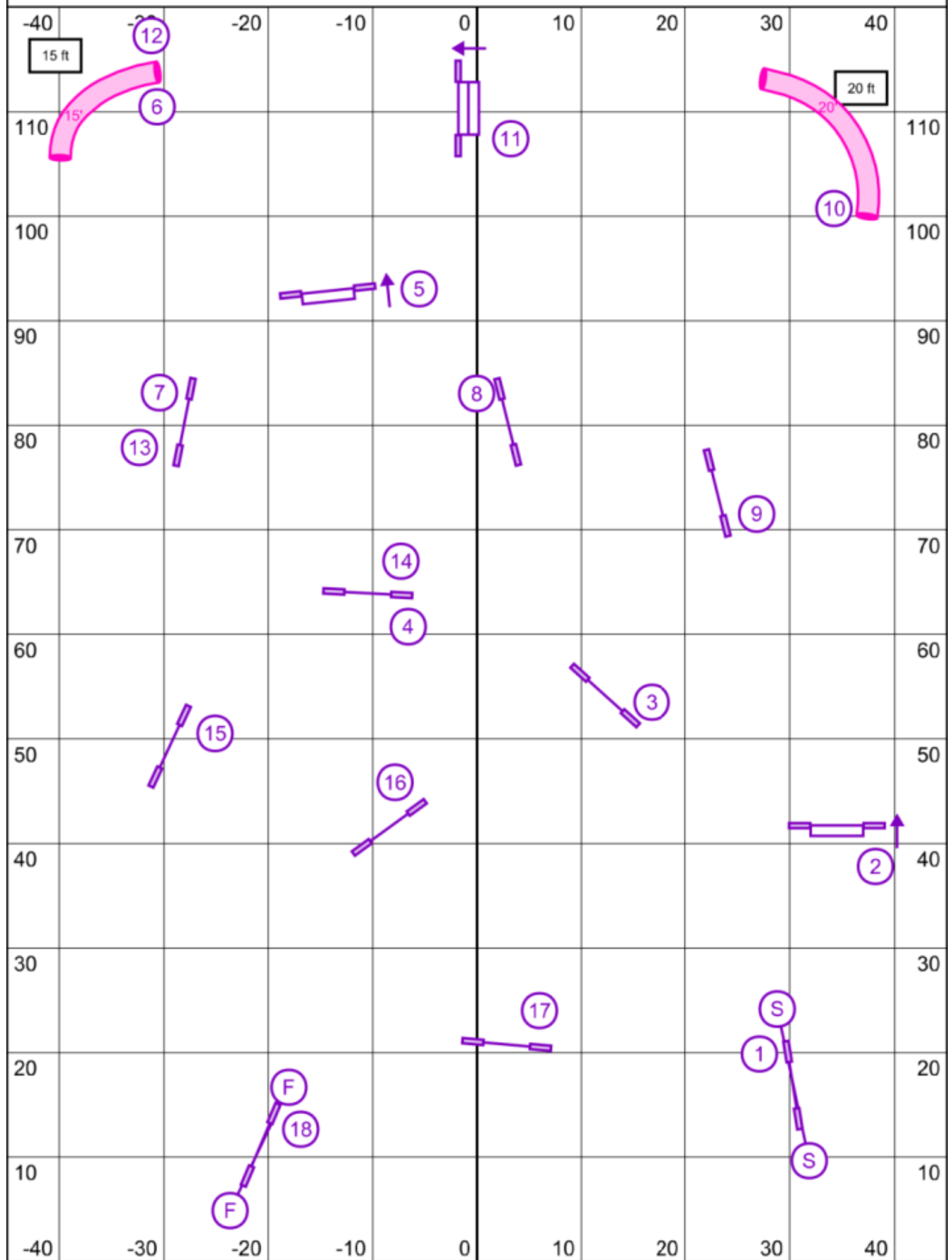
25 sec opening (18 pts needed in opening)

START JUMP - BIDIRECTIONAL

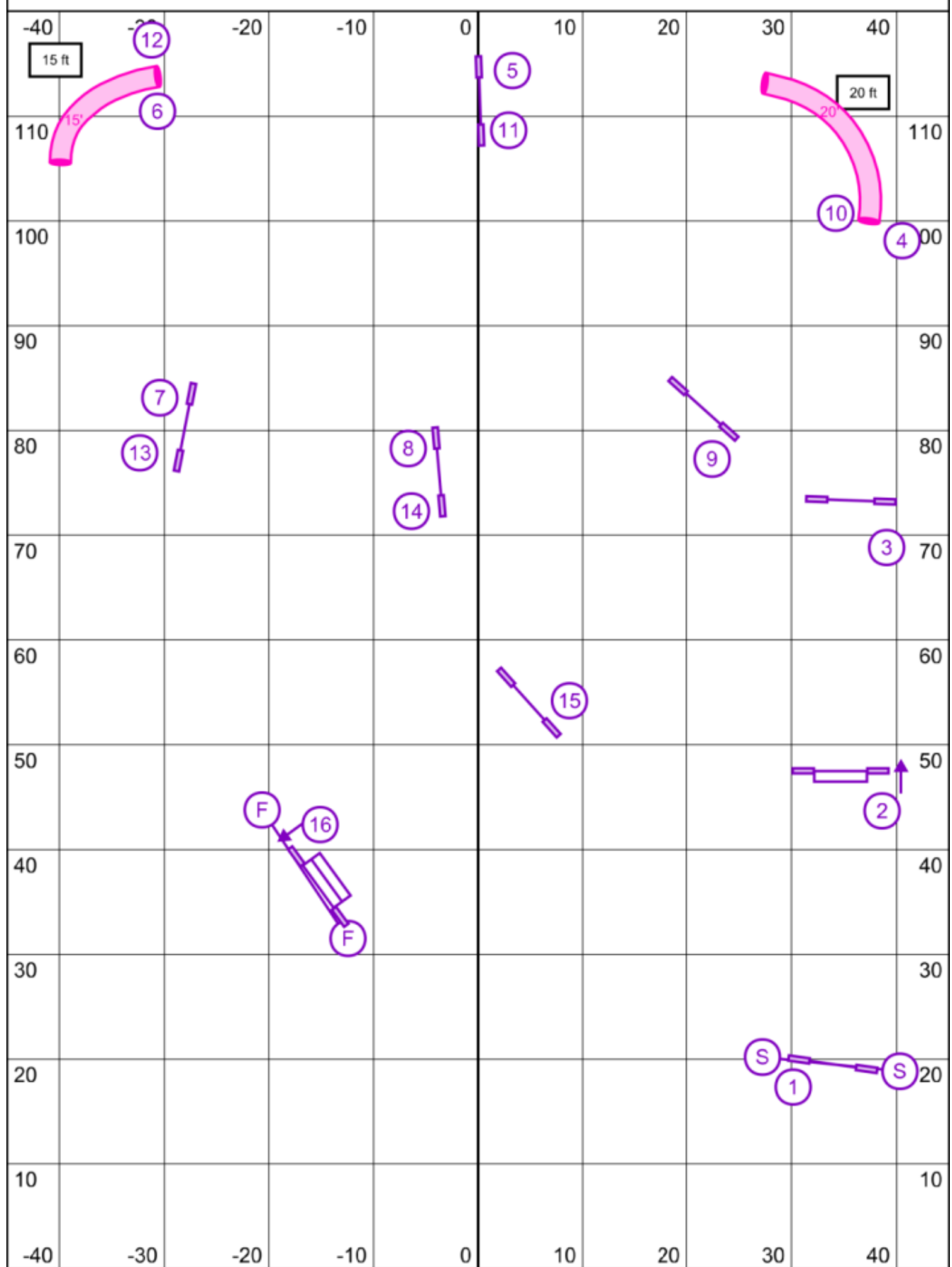
C24/20 = 16 sec C16/12 P20/16 = 17 sec C8 P12/8 = 18 sec P4 = 19 sec Vet = +3 sec

No contact to contact, back to back OK

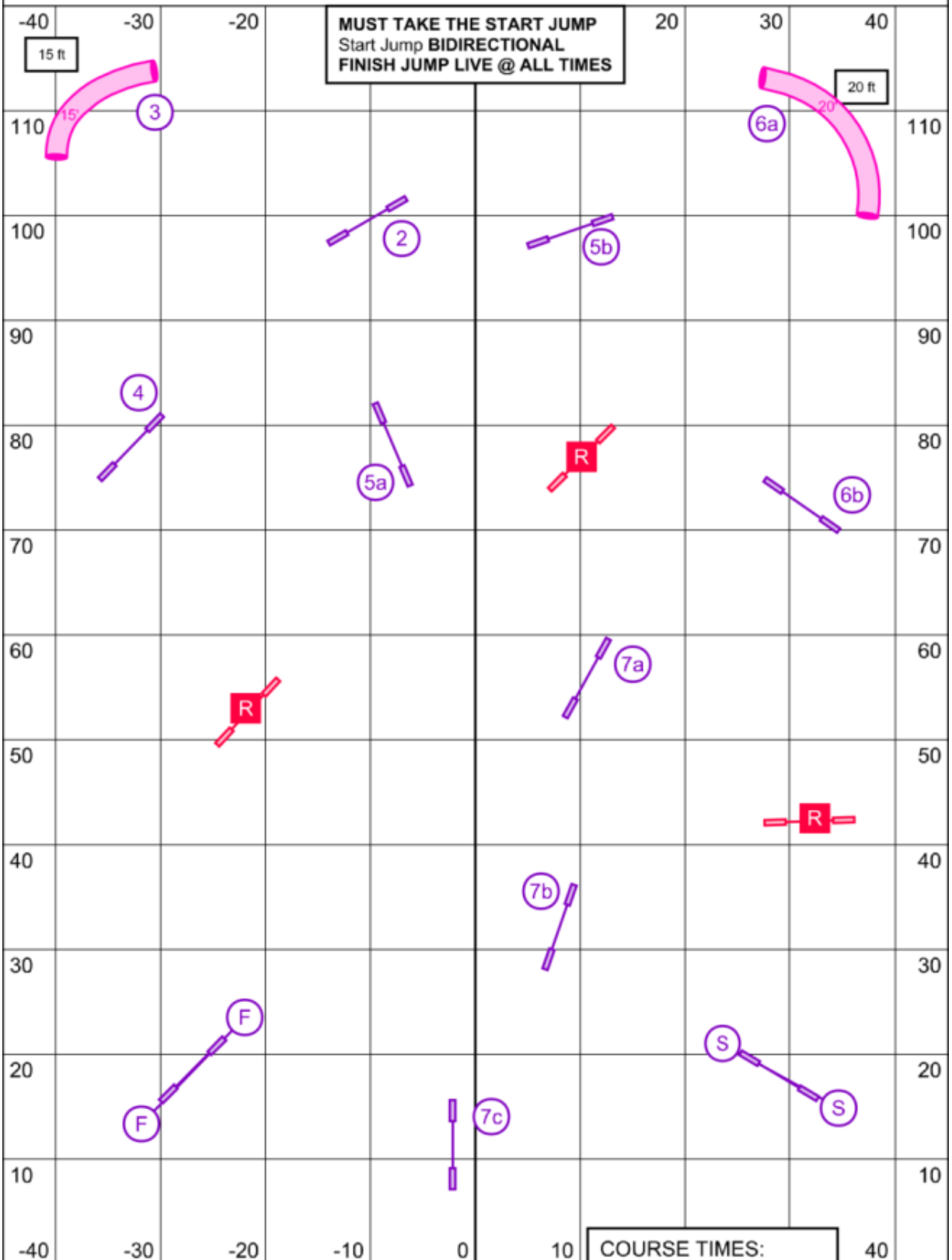

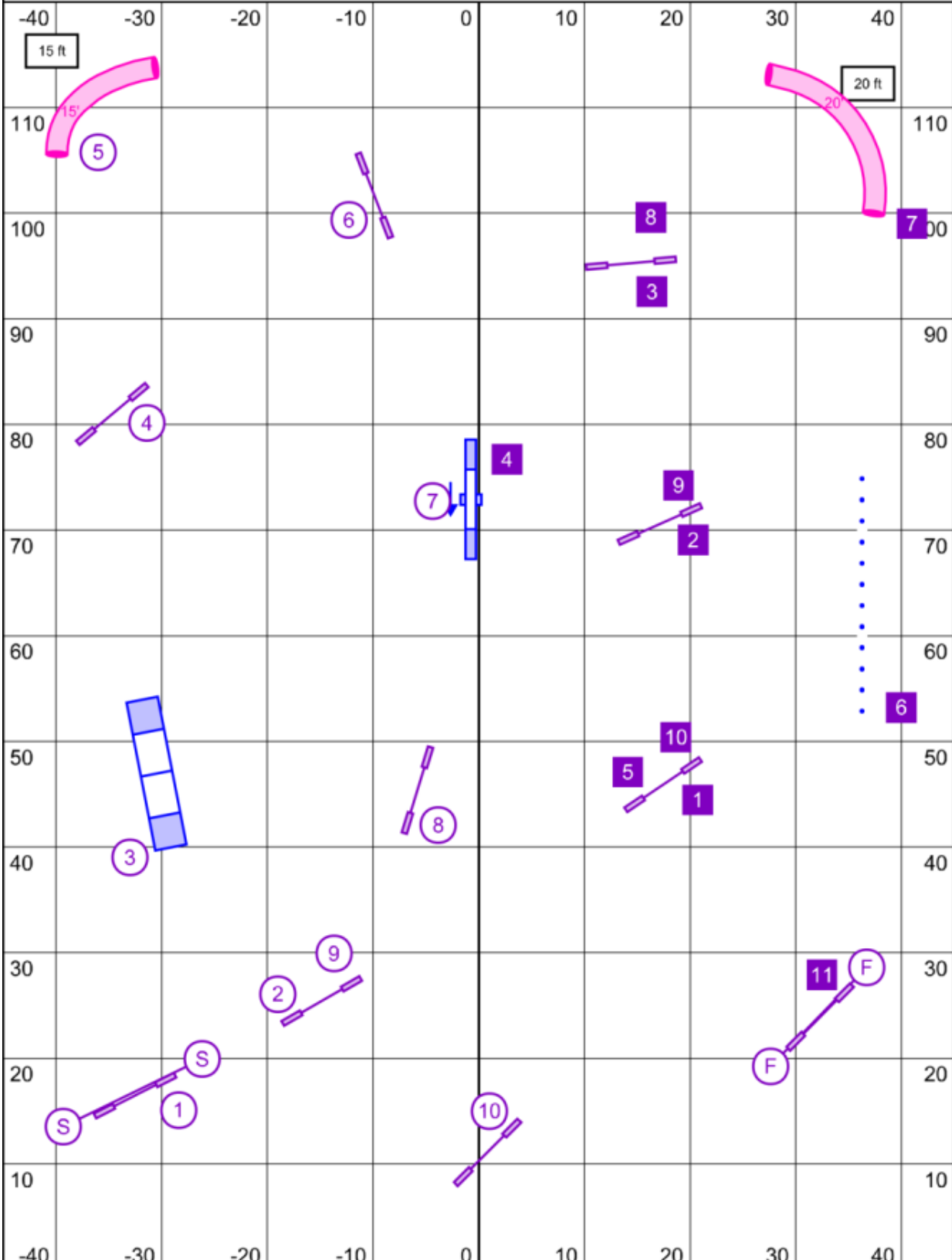


MASTERS/P3 SNOOKER Riverside Canine August 9, 2024 Judge: Rebecca Hill

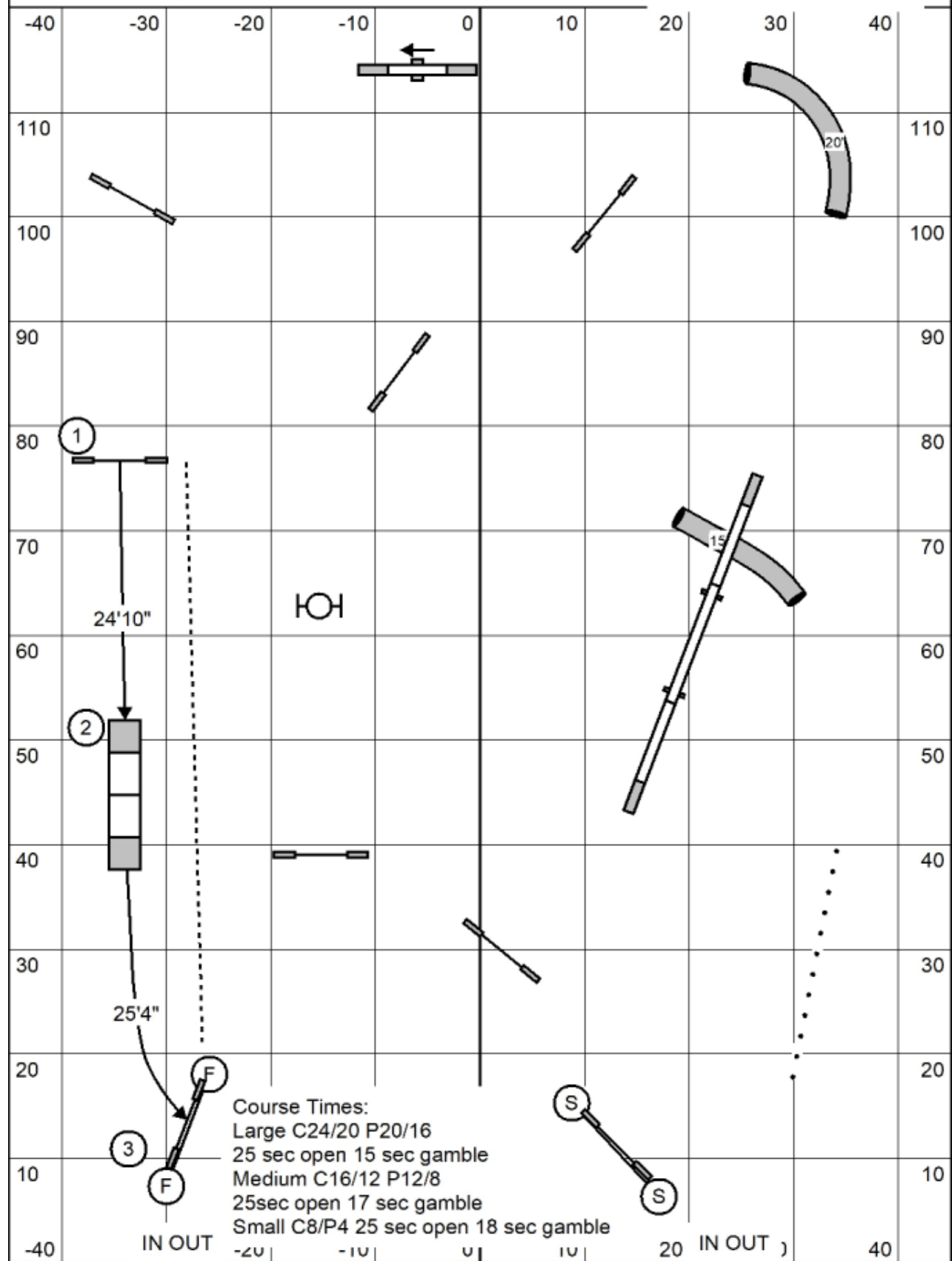
Mixed height pairs can choose sides

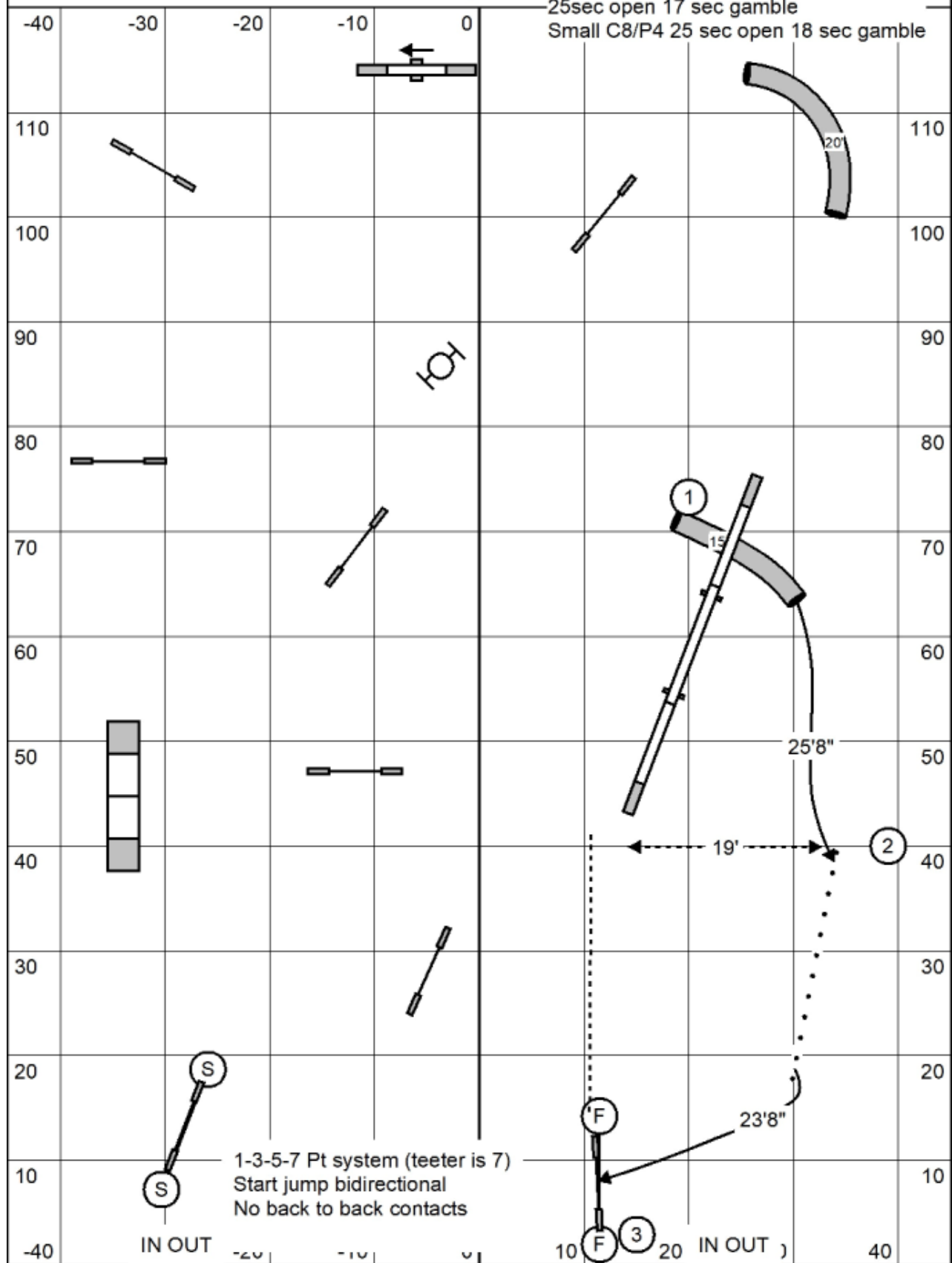
1-3-5-7 Pt system (teeter is 7)

No back to back contacts



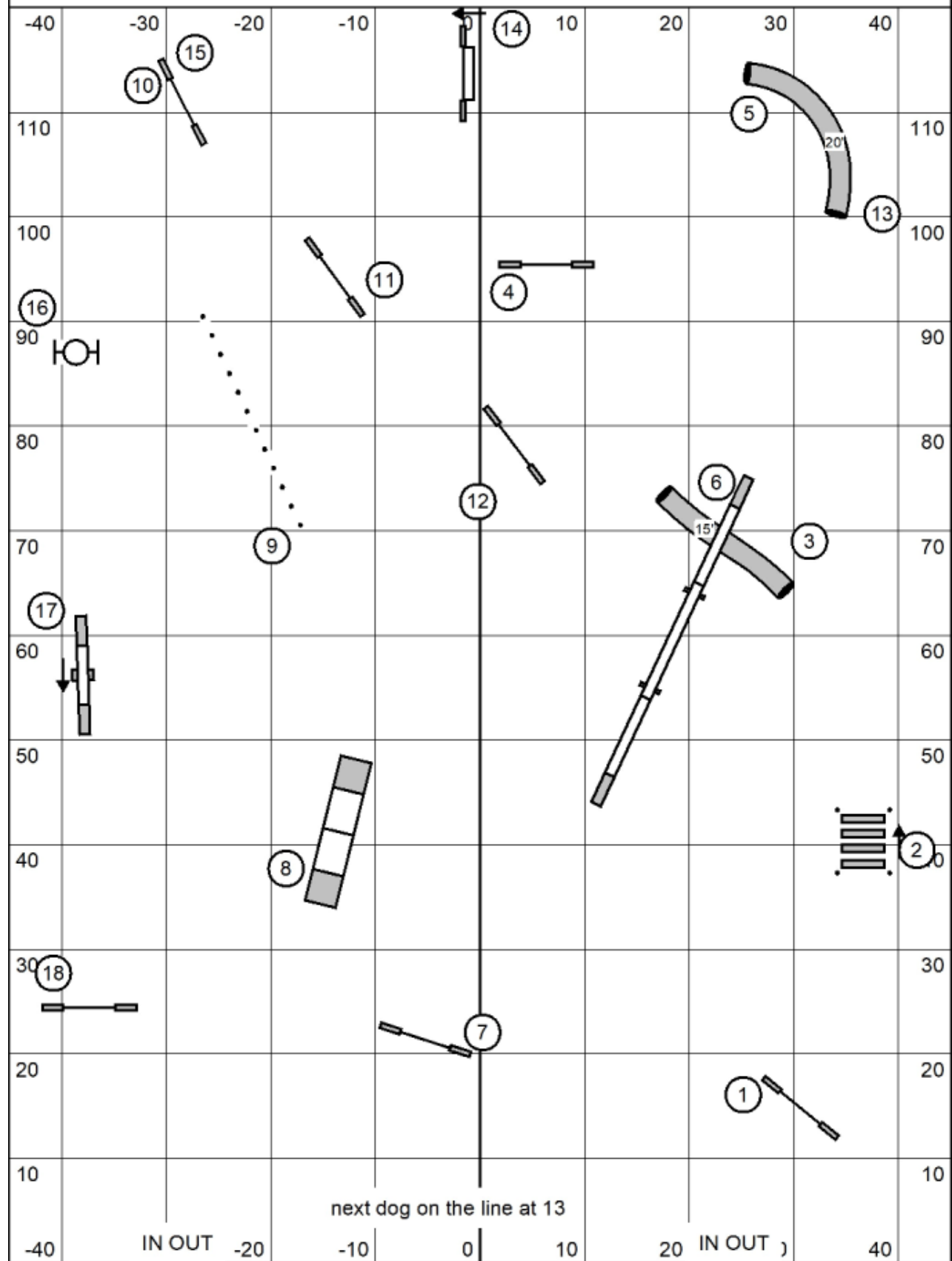
