General Trial Information:

Important Trial Information:

- A previous email was sent containing information regarding your entry. - **Bait and toys:** These must be at least ten feet from the ring. Use the "bait baskets" provided just outside the gates to store your bait bags.
- All exhibitors must pick up after their dogs in all areas of the campground. Please use the trash cans for dog pick-up.
- **Campground:** If you are camping or staying in a cabin at Hadley's Point Campground, please make sure you check with the staff for the time you need to be off the campsite, or out of the cabin. The campground does have required check-out times. Remember, they have other guests coming in on Sunday.
