Miscellaneous will be offered first thing Friday and Saturday mornings. Anyone entered in the trial can enter this class and warm up. Cost is \$10.00 per run, sign up when you arrive.

**THE TRIAL SITE WILL BE OPEN TO COMPETITORS AT 7AM. Please DO NOT enter the building prior to this time as the committee needs the uninterrupted early morning time to set up the smoothly running happy trials you have come to expect.**

**Dogs may only enter and exit through the far door directly into the ring area. Dogs may not enter through the front door.**

Join us on Saturday for our potluck BBQ – this will be held outside if the weather cooperates or indoors if it does not. Bring a side or dessert to share. Bring meat/meatless grill-able meals and we'll toss them on the grill/griddle for you!

#### **Conflicts:**

We are fortunate that both the UKI and USDAA organizations allow trials to be held in conjunction with another trial – same trial venue, same day, and same weekend.

Many of our competitors have chosen to participate in both organizations at this trial so we do our best to accommodate everyone.

We MAY need to extend a walk or briefly hold a ring so that competitors can walk in both rings. These delays will not be longer than having to wait for someone running multiple dogs (they are provided with a 7-minute break).

Competitors MAY need to move themselves in the run order to avoid conflicts.

We will be announcing ANY time adjustments throughout the day.

It is imperative to the success of our trial, to UKI & USDAA, that we (competitors, volunteer workers and judges) are willing to be flexible and accommodate competitors who choose to run in both organizations.

### **Course Maps**

Course maps will be posted to the MyDogEntry.com Website. They will also be posted at the site for competitors to view or take pictures.

Competitors may order printed maps for a fee of \$5 a day. They will be available for pick up daily at the start of each day. Simply email Val at K9AS@comcast.net

Please note USDAA maps can be posted early where as the UKI maps cannot get posted until 7:00am each morning.

Measuring can be done throughout the day. If you have a permanent height card from another allowed venue, just use that and your dog will not need to be measured

WWIS has specific potty areas for the dogs. Please only let your dogs potty in these areas. Do not let your dogs potty on the building or in the grass areas directly alongside the buildings

Please bring ground cover for under your crate or X pen **THIS IS REQUIRED**

We can crate and tent outside on the grass, if preferred.

Please bring your own chairs

Only water and dog treats are allowed in the turf fields.

We will have 7-minute walk throughs. The ring will be cleared, and the first dog will be on the line in 3 minutes

Those dogs entered in Masters/Pill Snooker (USDAA) cannot be moved in the running order. The only exception to this USDAA rule is if you are running more than one dog and the dogs are within 10 dogs of each other in the running order you may only move UP in the running order

A warmup area with a single jump will be provided for competitors. No other obstacles may be set up and/or used at the show site for training, warm-up, or any other purpose. This includes anywhere on the grounds or parking areas.

Dogs must be on leash or crated unless in the ring or when at the warm up jump. Competitors are RESPONSIBLE for the behavior of their children and/or dogs and the dogs or children in their care. Please DO NOT tie your dogs out and/or leave them unattended at ANY time for ANY reason.

Please pick up your dog's poop (or any other you may see); trash containers will be provided for disposal. Anyone who does not pick up after their dog will be asked to leave. No refund, no exceptions!

VOLUNTEER SCHEDULE THANK YOU in advance to everyone who volunteers to help out. We are only as good as our fabulous workers! Our Volunteer Ring Coordinator is Meg Haviland and Lynn Thibodeau. They will be asking for help throughout the weekend; All volunteers will receive raffle tickets for our worker raffle.

**Mulligan Runs:**

You can run a course a second time (after the class has finished) for a non-qualifying opportunity to try a different handling option, rework part of the sequence, fix your criteria, whatever it is that you want! FEO rules apply. Mulligan runs cost \$5 ,you can sign up and pay at the gate!
