Please don't arrive or use the fire lane area prior to 7am.

There will be **NO set-up of personal crates on Friday night** for this trial.

A previous email was sent containing information regarding your entry. It is YOUR RESPONSIBILITY to check this information carefully and notify the trial secretary of any errors or omissions as soon as possible. Most errors CANNOT be fixed on the day of trial. If you do not receive an answer, assume that the secretary did not receive your email. ALL emails will be answered if received. All move-ups for Standard, FullHouse and Jackpot MUST be made by the end of the day on Sat. NO changes will be made on Sun am or in other non-repeated classes. A form will be at the ribbon table for you to request a move-up for Sun.

Report any scoring issues before leaving at the end of the trial. No errors will be corrected after the trial is over.

Please volunteer to work. A worker schedule will be posted online and at the trial. The online link is included in the attached email.

There will be no food service on site. Please bring what you need for you and your dog. There are many local eating establishments that deliver. Anyone with snacks or individual treats to share is invited to do so.

Crating information:

Please stack your crates. We must all fit into the classroom. Quiet dogs may be crated in the arena. See a committee member for direction on arena crating. Competitors may use their own chairs in the viewing area for limited periods of time. Please keep them low-backed and non-reclining.

The All Dogs employees at the front desk have nothing to do with the trial. Come to one of the committee members for the trial if you have questions or concerns. (Sue Fontaine, Liz Shattuck, Michele Simard, CJ Dame, DeeAnn Decker, Kris Robertshaw)

Food, drink or clickers should not be inside the arena. Remember, flexi leads, ex-pens, and tacky paw substances are not allowed in the building.

All dogs must be on leash or crated unless in the ring or when in the warm-up area. There will be a ZERO tolerance policy for this rule. Offenders may be asked to leave without refund. All exhibitors must pick up after their dogs. Please use the trashcans outside for dog pick up.

It is important that you be on time for your run. Per CPE rules, any dog not set to run when their turn comes, may be skipped. Return to a height is at the host club and judge's discretion.
