#### NOTICE TO EXHIBITORS

\*The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

\*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. A dog that suffers an injury and/or illness or bitches in season may be eligible for a refund of 50% of the entry fee. Requests for refunds must be submitted to the trial secretary by the end of the last day of trial. They must be in writing and be accompanied by appropriate documentation from a vet on their stationery or letterhead stating the reason for the request. There will be no substitutions of dogs in lieu of dogs withdrawn.

\*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

\*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. \*Exhibitors are responsible for complete, accurate, and legible information on the entry forms.
