INFORMATION FOR TRIAL

BUILDING: The building will be open at 7:00 a.m. on both Saturday and Sunday. **First dog will be on the line at 8:00 a.m. both days.** We will do walk throughs at least 15 minutes before the first dog is on the line – please be ready to go.

CHECK IN: My Dog Entry will be used for checking in. When it is available, a button will appear at the top of the webpage...I don't remember the exact time, but sometime on Friday.

INDOOR CRATING: Please be courteous and do not take up more space than necessary.

WALK THROUGHS: Will be split only if necessary and will be limited to five minutes if they are split. If walks are split, there will be NO 5 minutes in between the walk and first dog on the line. To keep the trial moving, please pay attention and be ready to go when it's your turn. We will be using AGILITY GATE. You can download the app to your phone. The website is agilitygate.com. The Agility Gate code will be 1125.

BRIEFING AND COURSE MAPS: Judge's briefing will occur before we start each day and course maps will be available the night before each trial day on My Dog Entry. Maps will also be posted at the trial site. There will not be printed copies available at the trial.

RESULTS: Results and stickers will be available. Please do not crowd the results table.

MOVE UPS: are available. Please notify Jeannine Beer regarding any move ups before you leave Saturday.

DAY OF SHOW ENTRIES: Day of show entries will be accepted all day both days up to 30 minutes before the added run's class starts. \$18 per run. Cash, check or PayPal (fees apply) will be accepted.

RIBBONS: Will be self served – however please maintain social distancing when obtaining your ribbons. Also notify us if you will be earning a C-ATCH or C-ATE.

FOOD: We will be doing a potluck. Please bring a food item to share. We'll definitely have chicken and rice. We do have limited outlets/ crockpot space. Please advise the trial chair, Teresa (tbarney2011@gmail.com) if you will bring a hot dish.
