There will be **NO set-up on Friday night** for competitors in this trial.

It is YOUR RESPONSIBILITY to check this information carefully and notify the trial secretary of any errors or omissions as soon as possible. Most errors CANNOT be fixed on the day of trial. If you do not receive an answer, assume that the secretary did not receive your email. ALL emails will be answered if received. Trial secretary: Sue Fontaine, <a href="miniaussies5@comcast.net">miniaussies5@comcast.net</a> Do NOT change your dog's position on the gate sheet unless you have a work or additional dog conflict, per CPE rules. Any change of order is determined by the judge or the committee, not the gatekeep.

All move-ups for Standard, Jumpers and Snooker MUST be made by the end of the day on Sat. NO changes will be made on Sun am or in other classes. A form will be at the ribbon table for you to request a move-up for Sun.

Report any scoring issues before leaving at the end of the trial. No errors will be changed after the trial is over.

**Please volunteer to work.** A worker schedule is posted online and will be at the trial. If you would like to learn a job, we will be happy to teach you.

**There will be no food service on site.** There are many local eating establishments that deliver.

## Crating, Prep and Hangout information:

Come prepared to stack your crates, especially if you are bringing nonentered dogs. Priority for crating space is given to dogs that are entered in the trial. If you plan on using your car to crate and bring an Ez-up for shade do not secure them with stakes in the ground. We have an underground sprinkler system that could be damaged.

Competitors may use their own chairs in the viewing area for limited periods of time. Please keep them low-backed and non-reclining. Because we are tight on space we need to be mindful of others dogs and people around us. Tugging and rough play should not be done in the arena where dogs are lining up to run. Competitors may also use the bathroom hallway to line up rather than the hallway to the boarding kennels or the warm-up area.

The All Dogs employees at the front desk have nothing to do with the trial.

Please come to one of the committee members for the trial if you have questions or concerns.(Sue Fontaine, Liz Shattuck, CJ Dame, DeeAnn Decker, Lenore Coombs)

Food, drink or clickers should not be inside the arena. Remember, flexi leads, expens, and tacky paw substances are not allowed in the building.

All dogs must be on leash or crated unless in the ring or when <u>actively</u> in the warm up area. There will be a ZERO tolerance policy for this rule. Offenders may be asked to leave without refund. All exhibitors must pick up after their dogs.

Please use the trashcans outside for dog pick up.

It is important that you be on time for your run. Per CPE rules, any dog not set to run when their turn comes, may be skipped. Return to a height is at the host club and judge's discretion.
