Running OrderThe Running Order for all 3 days is included at the end of this document. We've
tried our best to arrange the order to avoid conflicts and leave as much time as
possible between runs of dogs owned by the same handler. But changes do
happen so please stay current on the posted gate sheets so you are aware of
changes made to the running order and don't miss your run.

IMPORTANT NOTES about the RUNNING ORDERS

For this year's April Agility Trial, BOTC has made a number of adjustments to the running order of classes and the grouping of dogs for walk thrus.

SATURDAY AND SUNDAY TRIALS: As outlined in the Trial Premium, the running order for the <u>Saturday and Sunday</u> trials has been altered from BOTC's usual patterns. This year:

- 1. The Excellent/Master and Premier classes for BOTH DAYS will start the day and will run first.
- 2. FAST (Saturday) or Time 2 Beat (Sunday) will follow, and
- 3. The OPEN/NOVICE Classes will then run thru the end of the day.

This running order will facilitate BOTC's invitation to Tatjana Salcedo to judge our Open, Novice, FAST and Sunday's Time 2 Beat classes as part of her evolution from a Provisional Judge to a fully accredited AKC Agility Judge. This is a process <u>all</u> new AKC judges must follow and it insures that a steady stream of qualified and experienced judges are available to Clubs for their trials.

The AKC relies on local clubs such as BOTC to host provisional judges and afford them the opportunity to gain judging experience. As part of this process we'll have an AKC Representative (David Hirsch) at the Saturday and Sunday trials to work with and observe Tatjana ... and answer any questions <u>you</u> may have about any aspect of AKC Agility Trials and the AKC's Agility Program.

If you have any questions about any aspect of the the judge accreditation process or what you'll see at the trials on Saturday and Sunday, feel free to also ask Tom O'Brien who is an AKC Agility Judge, a VMO and has been through the process himself.

| | Please recognize that each of us needs each other to keep this a viable site for all of us. If we're all polite, there should be plenty of parking at the trial site. | | | | | | | |
| <u>Armbands</u> | Armbands are no longer required by AKC. | | | | | | | |
| Face Masks | Covid is still with us though rates are low. Face masks may be worn but are not required. BOTC will have face masks and hand sanitizer on hand should you need them. BOTC reserves the right to modify this standard should the wearing of masks be required by the State of Vermont or the Town of Shelburne. | | | | | | | |
| RV Parking | RV's will again park in the north parking area – the area immediately adjacent to the Field House. | | | | | | | |
| | The rest of us can now park anywhere in any of the 3 lots EXCEPT: | | | | | | | |
| | 1. Please don't park on the shoulder of the road or on the grass. The ground is often soggy and if you sink in, you might need a tow truck to get out and you'll be responsible for the damage to the lawn. | | | | | | | |
| | 2. Please don't park in any of the spots labeled for use by the bike touring company. | | | | | | | |
| <u>Set Up</u> | Friday - The building will open at 9:00 AM for exhibitor set up. | | | | | | | |
| | We'll be unloading Max 200's equipment and setting up the ring starting at 8:00 AM and could use a hand if you can help. | | | | | | | |
| | Please be careful when unpacking your vehicles and crossing the driveway as Friday is a business day and the athletic club can be a busy place in the morning. | | | | | | | |
| | Saturday and Sunday - The building will open at 7:00 AM. | | | | | | | |
| <u>Measuring</u> | All dogs without a jump height card will need to be measured. There will be at least one VMO at the Friday Trial and a VMO and an AKC Rep on Saturday and Sunday. See Tom O'Brien if you need to have a dog measured. | | | | | | | |
| | • Those dogs competing without AKC height cards ("temporary" or at least one, yellow "permanent" height card) will need to be measured by the VMO before each dog's first run of the weekend. Please plan to arrive onsite at least 1 hour prior to the start of your class to allow plenty of time for measuring. | | | | | | | |

| | • Dogs between 15 and 24 months old only need one measurement and receive a "Temporary" height card that allows them to compete without further measurements until they turn 2 years old. | | | | | |

| | • Once a dog turns 2 years old, the measuring process starts again but this time each dog must be measured at least twice by two different VMOs or AKC Reps. | | | | | |
| | • Dogs over two years old that already have the first of the required 2 permanent height card measurements <u>will need to be measured for their second</u> <u>measurement</u> at some time over the weekend. Please check with the VMO to schedule a convenient time for both of you. | | | | | |
| <u>Bathrooms</u> | The Field House has restrooms and showers. These are open and available for our use. As we have done in the past, we will re-sign the Men's Restroom as a Unisex Restroom. The Women's Restroom shall remain exclusively Women. | | | | | |
| | The Town of Shelburne also owns a small restroom building adjacent to the parking lot. This building is not expected to be open this weekend. | | | | | |
| <u>Crating</u> | You have the option of crating from your vehicle or within the designated crating area inside the building. If crating from your car, please don't expand into or block adjacent parking spaces. Crating space within the building has been adequate in the past but we ask that you respect the aisles and that you try to keep your crates and other belongings fairly compact. We ask that X-pens only be used if you are crating multiple dogs. | | | | | |
| | As you will note, trial numbers for this event are again lower than is usual for BOTC's April trial – a likely byproduct of the local hotel rates and the addition of new trial sites in New England and Eastern New York. However, in the case of the crating area, this means there will be more space than usual. | | | | | |
| <u>Volunteers</u> | As always, agility trials run because we all volunteer to help. Ring crew volunteers will get paid in actual cash for classes worked. Course builders names will be entered in a daily raffle. We'll also have some other raffles over the course of the weekend. | | | | | |
| | BOTC's Volunteer hospitality operations will provide water, coffee, tea, and fizzy water (selzter) for volunteers with snacks and munchies. | | | | | |

DIRECTIONS TO THE TRIAL SITE:

From CANADA, NH, MA, CT, ME and RI: The Field House is approximately 6.5 miles from Exit 13, I-89.

- Take Interstate I-89 to Interstate I-189 (exit 13).
- Follow I-189 approximately 2 miles to its termination.
- Turn left onto US Route 7 south (Shelburne Road) and follow south to the Village of Shelburne.
- At the traffic light in the center of the Village, turn right onto Harbor Road.
- After crossing the railroad tracks, turn right at the second street onto Athletic Drive.

From New York State:

- Travel north on Interstate I-87 (The Northway) to Exit 20 (Queensbury).
- Turn left and follow the signs for Route 149 to Fort Ann.
- In the center of Fort Ann, turn left at the traffic light and drive north on U.S. Route 4 for about 19 miles to Route 22A in Vermont.
- Turn left on to Route 22A North and drive 40 miles thru Vergennes to its intersection with Route 7.
- Turn left on to US Route 7 north and drive to Shelburne.
- In the Shelburne village turn left at the traffic light at the gas station on to Harbor Road.
- After crossing the railroad tracks, turn right at the second street onto Athletic Drive.

DIRECTIONS TO THE EMERGENCY VETERINARIAN

Directions to Burlington Emergency Veterinary Services (BEVS):

Go out entry drive (Athletic Drive) from The Field House: Turn left onto Harbor Road. At the traffic light turn left (north) onto US Route 7 (Shelburne Road). Turn right onto I-189 North and merge onto I-89 South to Williston/Montpelier. Take I-89 Exit 12 (next exit) and turn left onto Vermont Route 2A. Proceed north 0.4 miles to the traffic light (Longhorn Steakhouse on left) Turn left onto Marshall Avenue. Go 1.4 miles on Marshall Avenue.. BEVS is on the left. **Estimated driving time: 15-20 minutes**.
