- **Bait and toys:** These must be at least ten feet from the ring. Use the “bait baskets” provided just outside the gates to store your bait bags.
- All exhibitors **must** pick up after their dogs in all areas of the fairgrounds. Please use the trash cans for dog pick-up.
- **Fairgrounds:** If you are camping or staying in a tent, please pick up after your dog. If you wish to stay an extra night, please let the secretary know, and pay for the extra night.
