There will be DAY OF SHOW entries (until we reach our maximum of 375 runs per day) at <u>\$18 per class</u> from 7:00 – 7:30 each day. Please bring a completed Premium. We would appreciate a check or correct change. If you know of someone coming for DOS, please advise them.

Final move up is June 9. There is a \$5.00 fee per class for **ANY** changes after June 9. Standard, Snooker and Jumpers move ups from Saturday to Sunday must be made on Saturday before leaving the trial site.

The running order will be posted by Thursday, June 12. Due to DOS entries and conflicts there may be changes in the running order. Please check your confirmation & posted running order for accuracy.

Trial setup will be Friday June 13 at noon. Anyone who comes to help is welcome to setup their crating area **AFTER** trial setup is complete.

This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
