The building will be open at 6:30 a.m. for set up. **Measuring will be from 7:30 to 7:45.** First dog on the line at 8:00 a.m. both Saturday and Sunday. Our judge will be Karen Hamilton (Apprentice) and Jackie Oricko (Supervisor).

There will be DAY OF SHOW entries (until we reach our maximum of 375 runs per day) at \$18 per class from 7:00 – 7:30 each day. Please bring a completed Premium. We would appreciate a check or correct change. If you know of someone coming for DOS, please advise them.

Final move up is June 9. **There is a \$5.00 fee per class for ANY changes after June 9.** Standard, Snooker and Jumpers move ups from Saturday to Sunday must be made on Saturday before leaving the trial site.

The running order will be posted by Thursday, June 12. Due to DOS entries and conflicts there may be changes in the running order. Please check your confirmation & posted running order for accuracy.

Trial setup will be Friday June 13 at noon. Anyone who comes to help is welcome to setup their crating area **AFTER** trial setup is complete.

This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
