Requests for refunds must be submitted to the trial secretary by the end of the last day of trial. They must be in writing and be accompanied by appropriate documentation from a vet on their stationery or letterhead stating the reason for the request. There will be no substitutions of dogs in lieu of dogs withdrawn.

*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
