Start at start jump taken in the direction noted on map.

- Contact to weaves is allowed

- No restrictions on taking closing gamble in the opening
- No refusals called in the closing
- Taking finish jump at anytime will end run.
- Finish jump must be taken at the end of your run in the direction noted on the map to keep your points.

1-5 Circles 15 pts
