

All Dogs Agility – CPE trial information

Thank you for your entry in the All Dogs Agility CPE trial on August 9 and 10, 2025 at the All Dogs Gym, 505 Sheffield Rd, Manchester, NH. Our judge is Barrett “Todd” Benson from California. **The trial run order catalog will be posted to mydogentry.com on Tues afternoon after the last day for move ups or changes, Monday August 4th.**

Facility opens 7:00 am

Measuring throughout the day

General briefing 7:40 am

Judges briefing and walk through for first class 7:50 am

First dog online 8:00am

Please don't arrive or use the fire lane area prior to 7am.

There will be **NO set-up of personal crates on Friday night** for this trial. Those helping with ring set-up may bring in their crates.

All move-ups for Standard, Colors and Jackpot MUST be made by the end of the day on Sat. NO changes will be made on Sun am or in other non-repeated classes. A form will be at the ribbon table for you to request a move-up for Sun.

Report any scoring issues before leaving at the end of the trial. No errors will be corrected after the trial is over.

Please volunteer to work. A worker schedule will be posted online at mydogentry.com on Tues afternoon. Trials run better and faster with your help. If you would like to learn a job, we will be happy to teach you.

There will be no food service on site. Please bring what you need for you and your dog. There are many local eating establishments that deliver. Anyone with snacks or individual treats to share is invited to do so.

Crating, Prep and Hangout information:

Come prepared to stack your crates, especially if you are bringing non-entered dogs. Priority for crating space is given to dogs that are entered in the trial where dogs are lining up to run. Quiet dogs may be crated in the arena. Because we are tight on space we must be mindful of other dogs and people around us. Tugging and rough play should not be done in the arena. If you plan on using

your car to crate and bring an EZ-up for shade do not secure them with stakes in the ground. We have an underground sprinkler system that could be damaged.

Competitors may use their own chairs in the viewing area for limited periods of time.
Please keep them low-backed and non-reclining.

The All Dogs employees at the front desk have nothing to do with the trial. Come to one of the committee members for the trial if you have questions or concerns. (Sue Fontaine, Liz Shattuck, CJ Dame, DeeAnn Decker, Lenore Coombs) Sue is happy to answer questions and help with concerns but requests that you not disturb her while she is scoring FULLHOUSE or JACKPOT.

Food, drink or clickers should not be inside the arena. Remember, flexi leads, expens, and tacky paw substances are not allowed in the building.

All dogs must be crated when not running, on leash when waiting their turn in the ring or when ACTIVELY in the warm-up area. There will be a ZERO tolerance policy for this rule. Offenders may be asked to leave without refund. All exhibitors must pick up after their dogs. Please use the trashcans outside for dog pick up.

All Dogs is a business and has restricted us from certain areas of the building. Specifics will be mentioned at general briefing.

It is important that you be on time for your run. Per CPE rules, any dog not set to run when their turn comes, may be skipped. Return to a height is at the host club and judge's discretion.
