



Thank you for entering the AgileDogs September CPE trial. We still have runs available if you wish to add some or if you know anyone who would like to join us. If you are already entered in the trial we don't charge the additional fee for day of show, you just pay the regular run fee.

General site rules:

Please do not arrive before 7:00AM.

The Speed limit on the property is 5MPH

This is a private residence – please respect and do not walk your dogs near/around the house or pool fenced in area behind the house. If we find anyone in the fenced in area by the house or pool they will be excused from the trial and no refund given. Please maintain a 10 foot distance from the ring fencing with your dog. We have zero tolerance for dogs peeing on the fence posts when being walked to the ring. There are many places to walk your dog on the property. Clean up after your dogs - please!

Parking-Parking is tight at the site but there are many shady areas that are not far from the ring. There is no parking in the area of the agility ring except for committee members. Handicap parking is along the building. Please do not block the double gates.

There is no crating of dogs in the training building. You may leave your chairs and crates in the building overnight if you wish.

To keep the trial moving and also because of space limitations, we ask that videos and photographs be taken from outside the ring. There are many great spots for videos and of course you are welcome to take photos in the ring with your dog during course builds and walk throughs. If you need assistance, please ask us.

Trash cans – will be in several locations throughout the site. There will be one blue recycle trash can, please only put recycle cans, bottles, paper and plastic in this can.

Scores will be available in the training building. Please do not bring your dog with you to check scores.

I know this is a lot of rules. We want everyone to be safe. But we also want EVERYONE TO HAVE FUN and to enjoy our trial and AgileDogs at JAZZ!

Course maps will be emailed the evening before the trial. Individual course maps will not be available at the trial.

There is no food vendor for this trial. Snacks and water will be provided for workers.
