



Medina Swarm October 4 & 5 CSS Trial

The building will be open at 7:00 a.m. for set up. First dog on the line at 8:30 a.m. both Saturday and Sunday.

Final move up is September 29 at 6:00 pm EST. **There is a \$5.00 fee per class for ANY changes after September 29.**

The running order will be emailed by Thursday, October 2, and will be posted on My Dog Entry the same day.

IMPORTANT NEWS: We have 2 judges for this trial and there will be searches taking place inside and outside at the same time so we can keep things moving. SEARCH ORDER WILL BE AS FOLLOWS: Containers Rd 1 and Rd 2 at the same time as Exteriors, followed by Interiors at the same time as Vehicles. Don't worry about search conflicts. Everyone will get to do their searches so please do not stress about "missing" a run.

The Exterior searches may take place at an adjacent business, and a local park. This is a fairly easy walk to either location and should pose no difficulties. If you have a physical limitation that prevents you from making the walk then you will be given special permission to drive to the search area.

Crating will be available indoors (there is ample space). However, you may choose to crate in your car as well. This is subject to change depending on where the judges choose to have their search areas.

Crate mats/tarps are required under all crates inside the building.

Lunch will be available by donation – pay what you can. We will have pizza on Saturday and pasta and salad on Sunday. If these options don't fit your needs, please plan ahead and make other arrangements. There is a water station on site so please bring a refillable water bottle. Bottled water will not be provided.

There will be a "warm up" area where you may practice. You **must use** provided scent and containers. Per CPE rules you are not permitted to use your own.

Parking is in the large back lot on the EAST side of the building. Please do not park in the small front lot on the southeast side. You will be asked to move.

Those who need to see Mandii (Trial Secretary) please do so before 8:00 a.m. day of trial.

Note per the CPE Premium

No changes to trial results will be made once the trial has been completed – handlers are responsible for the accuracy of information in their confirmation from the trial secretary (dog's info, level, height category and/or jump height, etc), prior to running in a trial, and for reporting any discrepancies of **posted results** prior to leaving the trial site each day. This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
