The building will be open at 4:30 PM on Friday, and 6:30 AM on Saturday and Sunday for set up. **Measuring will be from 5:30 to 6:00 on Friday, and 7:30 to 8:00 on Saturday and Sunday.** First dog on the line at 6:00 PM on Friday, and 8:00 AM both Saturday and Sunday. Our judge will be Jim Murrin.

There will be DAY OF SHOW entries (until we reach our maximum of 375 runs per day) at \$18 per class from 5:00 – 5:30 on Friday, and 7:00 – 7:30 on Saturday and Sunday. Please bring a completed Premium. We would appreciate a check or correct change. If you know of someone coming for DOS, please advise them.

Final move up is October 13 at 6:00 pm EST. **There is a \$5.00 fee per class for ANY changes after October 13.** Standard & Wildcard move ups must be made before leaving the trial site.

The running order will be posted by Wednesday, October 15. Due to DOS entries and conflicts there may be changes in the running order. Please check your confirmation & posted running order for accuracy.

Trial setup will be Friday October 17 at Noon. Anyone who comes to help is welcome to setup their crating area **AFTER** trial setup is complete.

No changes to trial results will be made once the trial has been completed – handlers are responsible for the accuracy of information in their confirmation from the trial secretary (dog's info, level, height category and/or jump height, etc), prior to running in a trial, and for reporting any discrepancies of **posted results** prior to leaving the trial site each day. This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
