Thank you for your entry in the ARF Agility Trial on May 17<sup>th</sup> and 18<sup>th</sup> at Agility and Rally for Fun, located at 659 Eastgate Parkway, Gahanna, Ohio 43230. [Please read through the following for important information.](#)

**NEW:** The Running Order and Maps will be posted on the [My Dog Entry](#) website. Instructions for accessing the information are included in the bottom of this document. The Run Order Catalog and Maps will NOT be emailed.

**EARLY SET-UP:** We are offering early set-up on [Friday, October 24<sup>th</sup> from 5:30-6:00PM](#). Please do NOT enter the building before 5:30pm, unless ARF has specifically asked you to help with trial set-up.

**WORKERS:** *PLEASE sign up to work!* The link for the Worker Sign-Up is in the Final Confirmation email and can be accessed directly on My Dog Entry.

**PARKING INFORMATION:** Parking spots located in front of the ARF building are reserved for ONLY handicapped, trial committee, judge, and photographer. All exhibitors should park anywhere behind the building, but do not block garage doors to other businesses. Additional parking is in front of the businesses to the right of the ARF building, or single-file on the right side of the road to the left of ARF, but it must be accessible for driving to the businesses located behind ARF. [If you plan to crate in your car, please email me and I will reserve a parking spot directly against the ARF building in the back.](#)

**OPENING TIME/BRIEFING:** The building will be open both days starting at 7:00AM. General briefing will start at 7:45AM and walk-thrus for the first class will immediately follow. Small dogs should be lined up and ready to run as soon as big dogs finish walking.

**RUNNING ORDER:** We are running Small to Tall both days. The Run Order is posted on the My Dog Entry website.

**COURSE MAPS:** Will be available on the My Dog Entry website at 6:00PM on the prior day. Full-size course maps will be posted at the site each day.

**CRATING:** Everyone is required to have a waterproof mat/tarp underneath their crates. Please consolidate your space as much as possible.

**MEASURING:** If your dog does not have a permanent P-Card height, the judge will measure dogs from 7:15AM-7:45AM each day of trial. I will send out a list of dogs requiring measurement in an email prior to the trial date.

**CLASS CHECK-IN:** Please check your dog in before each class. The Gate Sheets will be posted near the ring entrance.

**WALK THRUS:** The course walk times are 5 minutes. Saturday and Sunday upper levels: Please listen to the morning briefing regarding how walk-thrus will be split. For lower levels, all heights walk together.

**COLLARS/LEASHES:** Dogs can now run with or without a collar. Collars should preferably be quick release style, a flat buckle, rolled leather, or flea prevention. No attachments of any kind are allowed on the collar. All handlers have the choice to put their leash in their pocket, safely loop around neck or waist, or drop it at the start line.

**LEASH BOXES:** This trial uses leash boxes. When you have completed your run, please immediately enter the leash box with your dog and leash your dog after you are in the box.

**RESULTS:** Results will be posted on the wall. [Sunday move-ups must be added to the Move-Up sheet located on the Results Display table by the end of the trial on Saturday.](#)

**RIBBONS:** Run result labels will be placed on Q ribbons, matched with respective placement ribbon, and laid on a table for exhibitors to pick up. If you choose not to take the ribbons, place them in the return box.

**FOOD:** [April's This and That Food truck](#) is scheduled to be at our trial both Saturday and Sunday. A list of nearby fast-food places is included at the end of this document.

Please pick up after your dogs, both at the trial and hotels. Bags and collection buckets are located at both the front and rear entrances. Potty areas are in the grassy areas in front & side of the building, across the street and the area along the street to the left of the building, and NOT the mulch & bushes in front of the ARF building. [DO NOT walk your dog on the grass in front of the other businesses.](#) All dogs MUST be on leash and under handler control, except in the ring or practice jump. No electronic collars are permitted anywhere on the trial site.

Please wipe both your feet and your dog's paws when entering the building. Please use the rags located at each entrance to clean both dog paws and human feet!

Snooker – 35C, 12  
Jumpers – 35C, 12

## DIRECTIONS TO AGILITY AND RALLY FOR FUN (ARF)

659 EASTGATE PARKWAY, GAHANNA, OH 43230

### FROM THE NORTH:

Take I-270S on the east side of Columbus towards Gahanna

EXIT at HAMILTON RD; turn LEFT

Turn RIGHT on MORRISON RD (2<sup>nd</sup> traffic light)

Turn LEFT on TAYLOR RD (2<sup>nd</sup> traffic light)

Continue to follow TAYLOR RD through the traffic light at Taylor Station Rd

Turn RIGHT on EASTGATE PKWY

- This is the point on Taylor Rd where a curved road sign is present
- ARF is the first entrance on the RIGHT
- The building is in the front, left of the complex
- DURING TRIALS: Parking in front of the building is reserved for handicapped, trial committee, judge, and photographer

### FROM THE SOUTH:

Take I-270N on the east side of Columbus towards Reynoldsburg/Gahanna

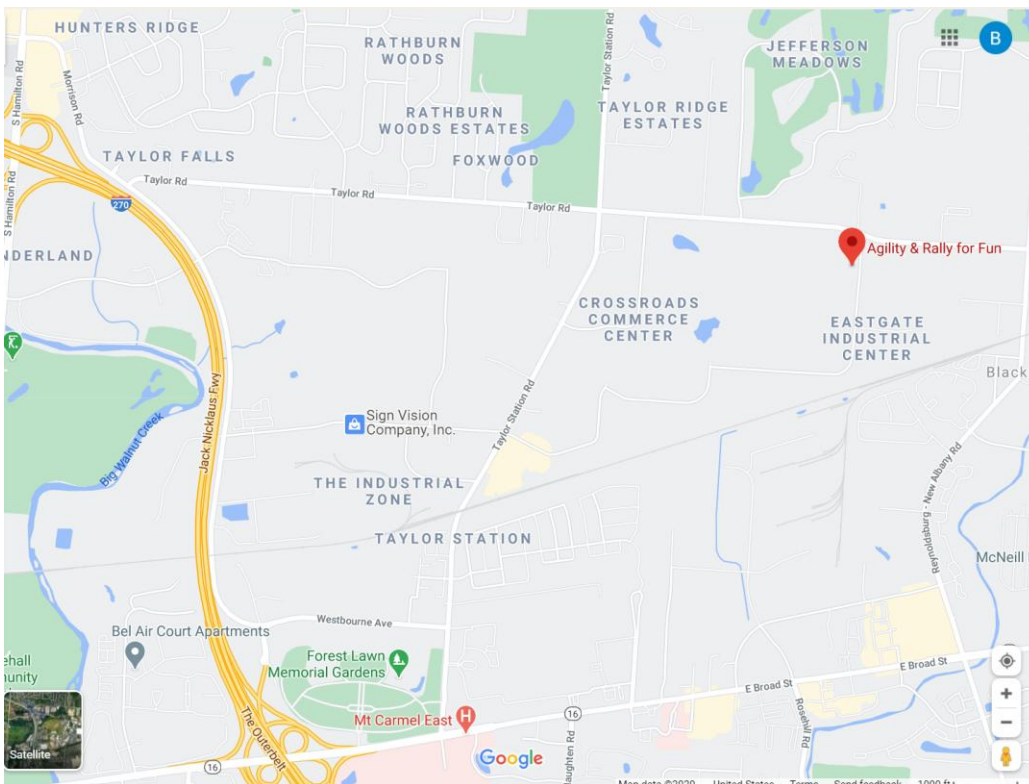
EXIT at E BROAD ST; follow exit towards TAYLOR STATION RD

Turn right on WESTBOURNE AVE and then left onto TAYLOR STATION RD (1<sup>st</sup> traffic light)

Turn RIGHT on TAYLOR RD (2nd traffic light)

Turn RIGHT on EASTGATE PKWY

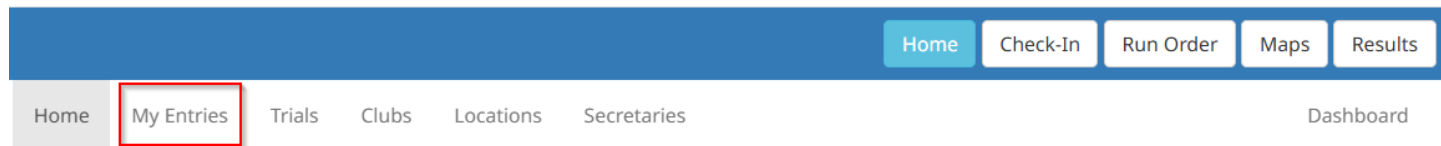
- This is the point on Taylor Rd where a curved road sign is present

- DURING TRIALS: Parking in front of the building is reserved for handicapped, trial committee, judge, and photographer



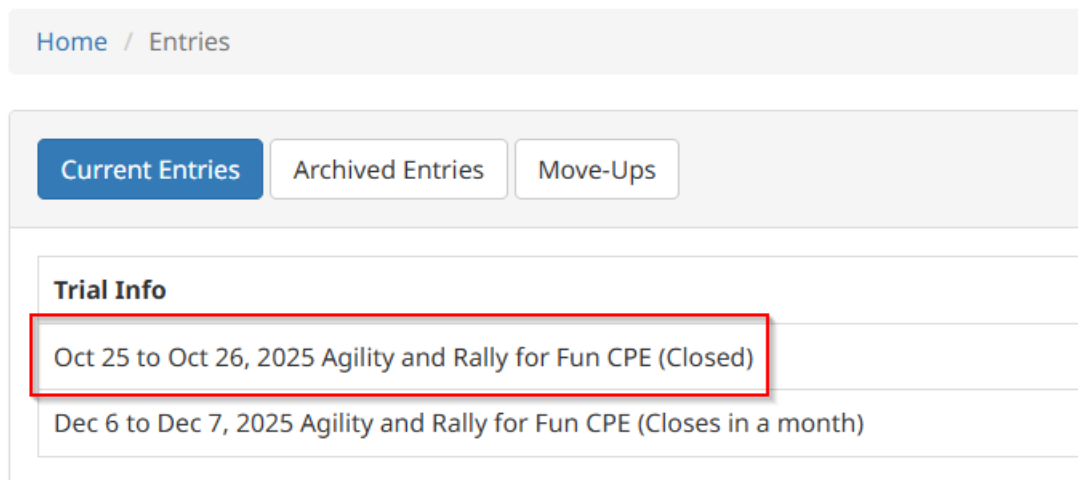

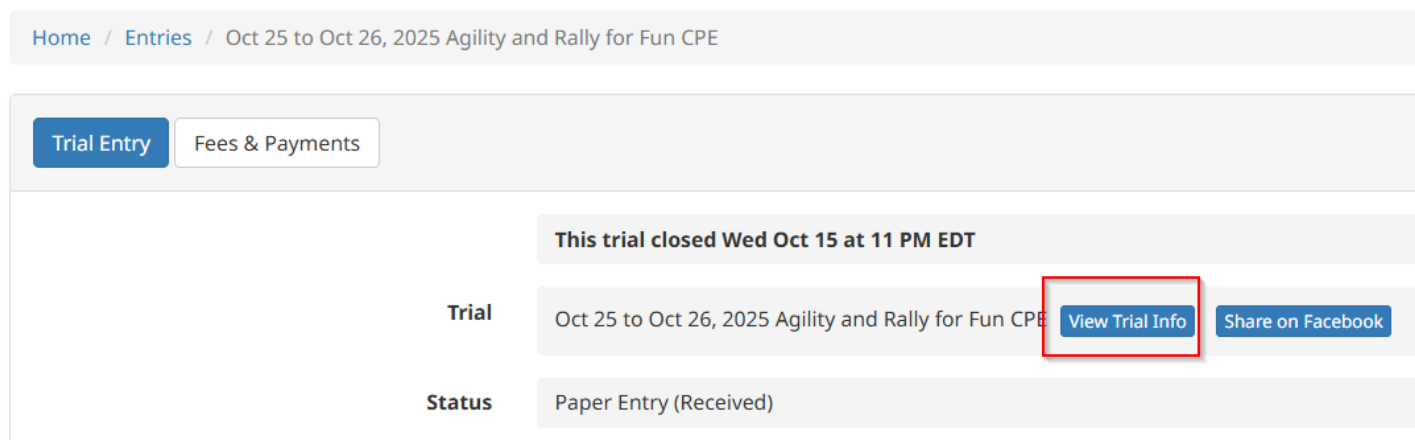
Once logged in, select “My Entries” on the Menu Bar:
