DIRECTIONS From the South (NYC and New Jersey): I-87 North (NYS Thruway) to Saugerties Exit 20, then right onto Route 212 East, then right onto Kings Highway for 3 miles, then right onto Industrial Drive. Dream Dogs Training Center is on the left. Cars keep to the right when entering.

From the North (Albany and Western Massachusetts): I-87 South (NYS Thruway) to Saugerties Exit 20. Turn left onto Route 32 South, then turn left onto Route 212 East, then turn right onto Kings Highway. Follow for 3 miles, then turn right onto Industrial drive and follow to the end. Dream Dogs Training Center is on the left. Cars keep to the right when entering.

- 5 mph speed limit on the property. Violators will be asked to leave the trial site and no refunds will be issued.
- Inside Crating is in our smaller classroom, you can enter through the double glass doors at the center of the building. Please bring a tarp for under your crate. You are allowed to have your chair in the crating room.
- There is no crating allowed in the agility arena at any time. No personal chairs are allowed in the agility arena. We
  will have chairs set up for viewing.
- Only dogs who are preparing to run are allowed in the arena while classes are underway, you can bring in your puppies/dogs in between classes if you want to socialize them.
- No dogs are allowed in the rest rooms at any time.
- We have limited space for tripods, they are only allowed to be set up in this designated area. If you are not running, please take it with you to allow space for others.
- The kitchen area is limited to committee members and volunteers only. Please do not use the refrigerator, sink, stove
  or microwave during the trial.
- When walking your dog, please stay on the Dream Dogs Property (we have neighbors who are watching us) We
  have plenty of room for you to walk your dog all around the buildings and on the grass areas.
- All dogs must be on leash and under control at all times except when using the warmup area or in the agility ring.
- We have additional bathrooms outside on the west side of the annex. The shower is only for our RV guests to use
  after event hours. These bathrooms are open to use throughout the day.
- No food, toys, clickers, or other aids or devices shall be permitted on the course or within ten feet of the ring at any time, except for toys used for FEO.
- No unsupervised children shall be allowed on the premises.
- Consumption of alcoholic beverages is not permitted during trial hours.
- No smoking in or within 100 feet of any building.
- You must clean up after your dog and place waste in the receptacles provided. Failure to do so may lead to being
  excused from the trial.
