- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Obstacles shall meet the specifications for obstacles in the current edition of Regulations for Agility Trials.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

- In the unfortunate event of a **Potty Accident** Paws for Thought Farm has a \$5 Potty Fee. Please see Sue or Bill for payment before leaving the Facility. **Please take a moment and familiarize yourself with the clean up instructions posted in the building. Your cooperation in this effort is appreciated.**
- Only clean shoes will be allowed on the ring Turf so please bring sensible outdoor footwear.
- Please clean up after your dog and place waste in the receptacles provided.
- **Do not allow dogs to urinate on buildings or trash containers.**
- Use the specified exercise area often to avoid accidents inside on the turf.
- Dogs **must be on leash at all times** (inside and out) unless they are in the ring or at the warm-up jump.
- No Food will be available.
- PLEASE: NO dogs in heat allowed on the premises.
