



Thank you for joining us at our Holiday UKI Trial! Holly Burchsted has designed the courses for both days; Lora Abbott will be judging on Friday and Holly will be judging on Saturday. We have 116 runs on Friday and 154 runs on Saturday.

This is our first trial using My Dog Entry! Each morning of the trial you can “Check-In” and see the “Run Order. If you are logged in to your My Dog Entry account when you click on either you will see your dog(s) listed. If you are not logged in, go to mydogentry.com and when you click on “Check-In”, you’ll see a list of trial locations. Click on your trial location and you’ll see a list of dogs. Scroll down and find your dog’s name(s). Click on your dog(s) and check in for each class. The same goes for “Run Order”. This can be done using your home computer, tablet or mobile phone.

### **IMPORTANT**

- Doors open at 8 am. General briefing is at 9 am with first dog on the line at 9:15.
- Course maps will be available on My Dog Entry when the doors open. The run order and maps will also be posted inside Little Paws and in the lobby of Big Paws.
- **Crating:** There will be plenty of crating in Little Paws.
- **MASKS:** All those who prefer to wear masks are welcome to do so.  
If you have had COVID or have been exposed to COVID in the past 14 days, please follow the CDC Isolation & Exposure Guidelines: <https://www.cdc.gov/covid>
- Please NO ANTI-SLIP SPRAY OR WAX MAY BE USED ON DOG'S PAWS. It damages the turf.
- Scores will be posted in Little Paws. Qualifying and placement ribbons are self-serve. Let us know if you get a title so we can give you a rosette!
- Thank you in advance for volunteering! ***There is no workers schedule so we are relying on you to volunteer.*** We will always need ring crew, leash runners and help building. We can't have the trial without your help!!!
- There will be chairs in Big Paws if you want to watch, but you may be recruited to work!!
- If your dog eliminates on the turf there is a \$20 cash penalty per incident. The Turf Policy is posted.
- The trial will be on Vimeo Livestream. The link and password will be posted. We have a monitor in Little Paws for you to watch the action. You are welcome to share the link with family and friends so they can watch you having fun with your dog
- Please ensure you understand the new criteria regarding dogs being measured. **UKI Rule Book edition 10:** If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3<sup>rd</sup> trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/ temporary measure. Any registered dog that only has a temporary measure, must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3<sup>rd</sup> trial and this measurement will be permanent. If you ask for a challenge measure when you have a permanent measure, you must state this when you are getting the dog measured so the correct protocol can be followed and you may not continue to challenge a measure when you have challenged it.

#### DIRECTIONS:

Paws 'N' Effect, 36 Corporate Ridge, Hamden, CT 06514

From I-91: – Take exit 10 (Rt 40) to end. Right onto Rt 10 (Whitney Ave) approx 1 mi. to left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From Rt. 15: South: Exit 62 to Whitney Ave. north. Continue on Whitney Ave (Rt 10 North) for approximately 3 mile. Turn left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From Rt 15: North: Exit 60 (Dixwell Ave). Left at end of ramp – go to intersection with Rt 10 (Hamden Town Hall on left). Turn left onto Rt 10 (Whitney Ave north). Go 2.1 miles to Sherman Ave. Turn left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From I-84: Exit onto Rt 691, then 1<sup>st</sup> exit onto Rt. 10. Follow through Cheshire into Hamden and take right onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.
