



**CPE Trial -December 26-28, 2025**  
**High Goal Farm, Louse Hill Road, Greenwich, NY**

Thank you for entering our last CPE trial at High Goal Farm! We are sad that our time at this great facility is coming to an end but we wish to thank Wendy and Dave for the many fun years and great memories that they have been a part of and wish them a wonderful retirement

Please read this confirmation letter, it contains important information on how the trial will run.

- If you are sick, please stay home. There are a number of illnesses going around so being cautious is recommended.
- In order to minimize disruptions when dogs are running we are requesting that you arrange to enter or exit at the doorway nearest your parking space being careful not to make noise if a dog is running. It is especially important not to make noise or create a distraction when our level 1 and 2 dogs are running.
- Dogs can be crated indoors, outdoors, or in cars, or any combination of these options throughout the day.
- The gate steward for each class will check in dogs during the walk through.
- Course maps for each day will be available on my dog entry. They will not be emailed. Copies will be posted on site, there will not be any additional copies available at the trial. Judge's Class Briefings will be listed on the course maps which will be available the night before each day of the trial. However, if you do need an explanation of anything at the trial the judge will be available to answer your question.
- We will have a leash runner that will use a leash grabber. However, you also have the option of carrying your leash with you during a run (doesn't need to be out of sight as long as you don't lure the dog with it or use it like a toy), or you can put it in your pocket or toss over the fence/towards the finish line.
- Results, labels, and ribbons will be laid out on large tables after the conclusion of each class. Title ribbons will be provided by a designated committee member. Please don't congregate at the ribbon table any longer than necessary, and please don't bring your dog when you go to check your scores. It makes it very difficult for those who are trying to enter the building to run to get their dogs in. Results will also be uploaded to My Dog Entry as soon as possible after each class is scored.
- A move up sheet will be posted by the ribbons table for next day move ups.
- If you believe there is a problem with your score, please check first with someone at the scoring area, or the Trial Secretary, to review your scribe sheet. If the problem can't be resolved there, we will arrange for you to speak with the judge.

**Site Details:**

**The site will be open at 7AM. Please do not plan to arrive before that time**

There are a few rules that we're asking people to follow. The pond, barn, livestock, woods, and Cerilli house are off limits to anyone at the trial. Anything else that is roped off is also off limits to anyone at the trial. There is a large field on the side of the agility building for exercising your dogs. Dogs not in the warm up area or in the ring must be leashed at all times. No smoking is allowed in the building. No alcohol or drugs are allowed at the trial site. Please clean up after yourself and your dog(s). There will be garbage receptacles for dog waste, cigarette butts, and any other garbage. Please bring water for your dogs. Please note that the building will be kept at approximately 58 degrees, so come prepared to dress in several light layers while in the building.

**MEASURING & CHECK IN AND RUN ORDER**

Thursday: There is no early setup for this trial

Friday: Measuring 7:15 AM; General Briefing followed by first walk through 7:30

Saturday: Measuring 7:15 AM to 7:30 AM; General Briefing followed by first walk through 7:30

Sunday: Measuring 7:15 AM to 7:30 AM; General Briefing followed by first walk through 7:30

There will be NO measuring of dogs AFTER the Judges Briefing begins each day – ALL DOGS WITHOUT A PERMANENT HEIGHT CARD MUST BE MEASURED before the Judges' Briefing in order to show that day – THERE WILL BE NO EXCEPTION

Please check your confirmation carefully because we may not be able to accommodate changes at the trial. All changes and corrections need to be submitted by Tuesday, December 23 at Noon. I may not be checking my email on Wednesday and Thursday as often as usual. All changes are made by email only.

**VOLUNTEERS:**

Please sign up to work via My Dog Entry. You may also sign up at the trial. Thanks to all who volunteer! Please do not worry about conflicts between classes you're working and classes you're running in. All workers will be accommodated. You can move your dog within a class to make sure you have time to concentrate on having a successful run with your 4-footed partner.

If your job for a given class is timer, scribe, assistant scribe, or gate steward, please report to the chief ring steward when the walk through for the class begins, so you can prepare for your job and so the judge can

brief you if needed – thanks! If your job is anything not already mentioned, you can report any time before or during the walk through.

**MOVE-UPS - CLOSING DATE:**

During the trial, move-ups will be taken for Standard, (only between days, CPE does not allow same day moveups) Jumpers, Wildcard and Colors at the show, and must be submitted to the Show Secretary before the completion of the last class of the day. Thank you for your cooperation. Please check your confirmation carefully. The deadline for contacting the secretary with move ups or corrections before the trial is 12pm on 12/23/25. There will be no changes after that date.

**Directions to the Trial Site:**

From North or South (Saratoga Springs): take Exit 14 of I-87 (Northway) and follow the signs for Rte 29, east. Go 9 miles on Rte 29 to Schuylerville. Take a right at Cumberland Farms. Go 0.3 miles to the light and take a left at the light, following Rte 29. You will pass the Washington County Fairgrounds. 2.7 miles past the fairgrounds, take a right at the Battenkill Vet Clinic and Aubuchon Hardware onto Rte 40, south. Go 0.3 miles. Take a left onto Bulson at the Elks Club. Go 0.4 miles. Take a right onto Hegeman's Bridge Road, Go 0.2 miles and take a left onto Louse Hill Road. Go 0.2 miles and turn right up the driveway to High Goal Farm.

From South or East, alternate route: Take Route 22 North through the towns of Petersburg and Hoosick. In Cambridge, take a left onto Route 372 West, and follow for 10 miles. Take a left on Hill Street (this is the end of Route 372, it's at a traffic light); follow for 1.4 miles (it becomes Hegeman Bridge Road). Turn left onto Louse Hill Road, follow for 0.2 miles and turn right up the driveway to High Goal Farm.
