

Hi Scent Sport Exhibitors,

Below are some reminders and some important bits of information for you about our event this weekend. Please read everything carefully since we have some very specific rules pertaining to this event.

1. If you are ill, please stay home. If GLOC deems an exhibitor ill at the event, it has the option to excuse that exhibitor.
2. The Secretary will be setup inside. You can arrive any time after 7:00am. Check in starts at 7:15am. Armband labels will not be used for this event.
3. The judge's briefing will take place outside 7:30 each morning with start time at 8:00a.m.. Remember: if you need clarification about anything, ask the judge at the start line before you begin your run.
4. **REMEMBER THE TIME CHANGE SUNDAY MORNING! DON'T BE LATE!**
5. The judges will do walk-throughs.
6. In your confirmation you have received the order of elements and classes. Classes are listed in the order they will be run. Please bring along a copy of your confirmation and the CSS guidelines either printed or on your phone.
7. The running order/check-in sheets will be posted in the vicinity of the Secretary or outside the entrance depending on weather.
8. Crating is out of your vehicle only; there is no indoor crating space at this venue. Parking is available in front of the community center. If anything changes on the parking after setup, I'll let you know. Please be flexible.
9. There will be no indoor spectator areas for this event. Videotaping will be allowed during all searches. Please do not ask a steward to video you. You must have your own designated person.
10. There are multiple fast food restaurants with 1 mile of the trial site.
11. Dog potty area is on the grass north of where you are parking. Please pick up after your dog.
12. Results and ribbons will be on a table inside near the Secretary. There will not be an awards ceremony. Pick up your own ribbons.
13. Class Transfers: Tell the secretary about any transfers. Since we have multiple rounds each day, make sure you tell the secretary about your transfer immediately after your run. The secretary will record your transfer information.
14. If you have your CPE scent sport title sheets, remember to bring them along with you so you can keep track of how your dog does. This will help you with class transfers. If you don't already have one, we will have them available at the trial.

Route to Trial Location

From Lincoln: Waverly Community Foundation 11120 N 141<sup>st</sup> St, Waverly, NE 68462. Head east on Hwy 6. Turn left at stoplight on 141<sup>st</sup> St just past Casey's General Store, by Fire Station. Venue is 0.3 miles on left side next to playground.

From Omaha via I-80: I-80 W to Waverly/Lincoln exit 409. Turn right onto US-6W. In 2.5 miles turn left at stoplight just past Casey's General Store, by Fire Station. Venue is 0.3 miles on left side next to playground. OR take exit 420 for NE-63 toward Greenwood. Turn Left onto NE-63S. In 1.1miles turn right onto Church Rd. In 3 miles turn left onto Hwy 6. In 5.3 miles turn left at stoplight on 141<sup>st</sup> St just past Casey's General Store, by Fire Station. Venue is 0.3 miles on left side next to playground.
