Agility Gate App

- We are using the Agility Gate App for class check-in, running orders, and course distribution.
- It is a free app for iPhone & Android phones. The access code will be 0131.

Measuring

- Please review the new measuring policy in section 4.5 in the [11th edition rulebook](#).
- From the UKI office: If a newly registered dog is under 3, a temporary measurement or proof of the dog's height must be done by the dog's 3rd trial. A permanent measurement must be obtained by a UKI official measurer between 12-18 months after the dog's first/ temporary measurement. Any registered dog that only has a temporary measurement must follow the above rule. If a newly registered dog is over 3, they must obtain a measurement by an official UKI measurer by their 3rd trial and this measurement will be permanent. If you ask for a challenge measure to your permanent measure, you must state this when you are getting the dog measured so the correct protocol can be followed. You may only challenge a measurement once.

Other Details

- Remember to wear **clean, dry shoes in the ring** and to familiarize yourself with [OTR's Gym Rules](#).
- As per UKI rules, **course maps** will be posted when the trial opens each morning and in the Agility Gate app.
- **Kayleigh Omang will be taking pictures** both days. Sign up at her [gallery](#) to be notified when photos are ready.
- Going to the US, West Coast, or Canadian Open? Consult the **Bye tracker** available at <https://ukagilityinternational.com/events/> and remember that byes must be earned by the same dog **and** handler team that is competing at the open. (If your dog is handled by someone else, make sure your final confirmation shows the correct handler. Let me know ASAP if it doesn't)
- If you have a **BIS**, please contact me ASAP. The BIS will remain in their running order and BIS will be designated next to the name on the running orders. The BIS must wear pants while inside, including when running. The handler/owner acknowledges the inherent risk of running a dog on an agility course with BIS pants on and assumes all risk by doing so.
- Our next UKI trials are the **May 22-24, 2026 Midwest Classic** at On the Run with Rosanne Wesmann judging and our local **UKI trial on Sept 19-20, 2026** outdoors at Animal Inn with Danielle Davis judging.
