DAY OF SHOW ENTRIES	We will be accepting Day of Show Entries from 7:00 – 7:30 AM and throughout the day at \$15 per run. Payment by cash (exact amounts appreciated) or check. You must have a CPE ID# in order to play. No entry to the site prior to 7:00 AM.
CHECK-IN	Show Check-in will be at 7:30 – 8:00 AM. No entry to the site prior to 7:00 AM.
MEASURING	If your dog does not have a CPE measurement, we will measure your dog. If you have a permanent measurement card from another agility organization, we will accept that.
JUDGING & RUNNING ORDER	<p>This is a one ring trial. Each class grouping will have a single walk-thru with all heights walking together. Please check at the briefing and listen to announcements during the day in case anything changes</p> <p>There is no judge in Speedway. We have volunteer Course Marshalls. The Course Marshalls attending this event will be Joy Lowe, Donna Gross, Renee Gillett, Cyndie Enfinger and Marla Reznitsky.</p> <p>If you have entered a team event without a designated partner, you will be paired with another dog.</p> <p>Class Schedule Sat. WATER & SHADE	This is an outdoor trial. Please be mindful of and prepare for Florida weather. There are trees on the property for shade. Feel free to bring shade tents if you crate in the field. Crating will be available near the rings, in the shade or in the fields.
EXHIBITOR INFORMATION & SETUP	<p>Setup is available on Friday January 23 from 1PM – 5PM.</p> <p>There will be a porta potty on site.</p> <p>Agility folks are the best at this, but just a reminder to please clean up after your dog at the trial site and at your motel. At the trial site, dog waste goes in designated areas.</p> <p>Dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.</p>
RV's	No campers or RV's allowed without the express written permission of the Trial Chairperson.
PARKING	There is plenty of free car parking available. Parking will be on grass in designated areas.
CRATING	There is plenty of room for your tents, crates and X-Pens. Crating will be allowed outside near the rings. You must be at least 10' away from the rings.

DIRECTIONS	<p>Playback Agility Field, 8150 Cleveland Drive, Punta Gorda, FL 33982</p> <p>Take exit 164 from I-75. Go north on US 17N (Duncan Road) toward Arcadia for 2.1 miles. Make a right on Mitchell Avenue. Mitchell Avenue becomes Cleveland Drive. Follow about 1 mile to 8150 Cleveland Drive.</p>

Follow Cleveland Drive to US 17 N (Duncan Road). Turn left onto US 17 N. Follow 17 N to I-75 North towards Tampa. Take exit 170 toward Count Road 769 S / Port Charlotte. Turn left onto Kings Highway. Turn right onto Veterans Blvd and follow for 6.9 miles. Veterans Blvd becomes FL-776. Turn left toward Murdock Circle, turn right onto Murdock Circle. Vet Clinic is on the right.</p>
HOSPITAL	<p>Fawcett Memorial Hospital, 21298 Olean Boulevard, Port Charlotte, FL 33952 Tel: (941) 629-1181 10.3 Miles, 19 Minutes</p> <p>Make a left onto Cleveland Drive. Follow Cleveland Drive to US 17 N (Duncan Road). Turn left onto US 17 N. Follow on Duncan Road for about 4.5 miles. Duncan Road becomes Riverside Drive and then E. Marion Ave. Turn right onto US-41 N / Tamiami Trail. Stay on US-41 N for about 4.3 miles. Turn right onto Harbor Blvd, Turn left onto Olean Blvd. Hospital is on the right.</p>
