Check in on **Friday, Saturday and Sunday** will be from **8:30-9 a.m. EST**  
**Trial Site is in Eastern Time Zone. Start Time each day is 9 am EST.**

Day of show entries will be taken during this time. Briefing and walk thru will be at 9 a.m., and judging will start immediately after. You will want to be present for all the class briefings for a thorough explanation of the rules.

**The gate will not open until 8:00 a.m. Please do not arrive before 8:00am as you will not be able to enter the property.**

We will be using one ring for our trial. The running order for each day is being emailed to all exhibitors.

The class running order is as follows:

**Friday:** Pitstop Rd 1/Rd 2, Slingshot Rd 1/Rd 2, Pole Position solo Rd 1/Rd 2, Pole Position Team Rd 1/Rd 2

**Saturday:**, Pole Position solo Rd 1/Rd 2, Hairpin Team Rd 1/Rd 2, Slingshot Rd 1/Rd 2, Pitstop Rd 1/Rd 2

**Sunday:** Pitstop Rd 1/Rd 2, Slingshot Rd 1/Rd 2, Pole Position solo Rd 1/Rd 2, Pole Position Team Rd 1/Rd 2

**From I-40 West**

Exit 320, Take a left onto Genesis (298N), Go 18.2 miles to Clarence Lee Rd (you will see a closed down store that says 4 Corners Market), take a left immediately after the market. Trial is at 2nd house on the left. GPS should bring you there.

**From I-40 East**

Exit 320, Take a right onto Genesis (298N), Go 18.2 miles to Clarence Lee Rd (you will see a closed down store that says 4 Corners Market), take a left immediately after the market. Trial is at 2nd house on the left. GPS should bring you there. If you are coming from I-40 your GPS may tell you to take Clarence Lee Rd earlier than the 18.2 mile mark, if there is not a market on the left than this is the 1st Clarence Lee Rd, you may take this also as Clarence Lee has 2 roads off of 298. If you are coming in an RV then you'll want to make the 2nd Clarence Lee Rd on your left at the corner of the market as this gives you a better angle into our driveway.

**RV's Do not take Barnett Bridge Road no matter what your GPS says, keep going and it will re-direct you. It is not an RV or Trailer friendly road. Your GPS will only tell you this if you are taking the back way in.**
