**Congratulations, you are entered in the above Doggie U CPE Agility Trial held at Doggie U K9 Academy**

This is your Trial Information letter.

**Crating** No guests or spectators allowed inside DU. Inside crating will be allowed. Crating is in crate room on the right or in the lobby. There are crates available for use on a first come first served basis. Crates may not be moved while dogs are running. **If you use a Doggie U crate it MUST be cleaned before you leave the show.** Doggie U highly recommends you bring your own crate. ***Also, please clean up the area around your crate, hair, food, water before you leave the trial.***

**Leashes** There will be a leash runner. Exhibitors will be allowed to put their leash in a pocket or tied around their waist when in the ring. ***As Per CPE RULES NO Flexi-leashes allowed.***

**Walk thrus**, May/Will be split in accordance with the original run order. If you move a dog, you will walk in your original group. Walk thru times may/will be shortened depending upon the number of walk thrus required.

**Video**, should you wish to video your run, please do not ask people who are working in the ring to record the video. A friend who is also entered in the trial may come into the arena to record the run. We request that you do not set up your recording device on its own or place it on ANY surface within the room.

**Treats/Toys** no food, toys or treat bags are to be left near the entrance of the ring or placed on any surface other than your own crate. Please do not leave your things on other people's crates.

### **General Site Information:**

Doggie U is an indoor site with heat and air conditioning and the running surface is rubber matting. The Doggie U parking lot and building will open **7:00 AM Saturday/Sunday**.

**Parking: There is limited reserved parking for those only working out of their car.**

**You may NOT crate in the building if you are working out of your car.**

**Potty area:** Is the grassy strip in front of the building, plus there is a pebble stone potty area located in the front-loading bay behind the dumpster. The well-kept grassy areas across the street from our building are completely **OFF LIMITS**.

**Crating, dogs may be crated in the building.**

**Doggie U House Rules:**

- Potty your dogs in the designated potty area ONLY.
- ALWAYS PICK UP AFTER YOUR DOG!!
- No dogs off leash at any time other than in the ring or at the practice jump.
- No squeaky toys or clickers are allowed in the building.
- Please close your crates even when they are not occupied.
- Keep your food and water bowls in closed crate or on top of crate. These things need to be kept out of reach of dogs walking through the building.

**Directions:**

**From Southern State Pkwy**, take exit 42 South, 5th Ave. Bay Shore. Stay to the left, make a left at the light onto 5th Ave, \*turn left onto Spur Dr. North, (there is a McDonalds on the corner), take first right onto 5th Industrial Court. Doggie U is on the left, and you'll see a sign for "Master Concepts", which is in the same building. Spur Drive North is just slightly north of Southern State Parkway.

**From Sunrise Hwy** take exit 43 North, 5th Ave., then follow from \*.

**From the LIE**, take exit 53, Sagtikos Pkwy, to Southern State Pkwy East, exit 42 North, then follow from \*. (Alternate route for commercial or large vehicles, LIE exit 53 (same exit as Sagtikos Pkwy) to Wicks Rd. Travel for 3.8 miles south on Wicks Rd, which becomes 5th Ave, then right on Spur Dr. North, right onto 5th Industrial Court.)
