Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Turn right onto Rogers Road, drive 1.6 miles. Turn left onto Detroit Road (Route 220), drive 0.7 Miles. Turn right onto Burnham Rd, drive .9 Miles. Turn left onto Pond Rd, drive 1.2 miles. Turn right on Garcelon, drive 2 miles to 119 Garcelon Rd.

From the South: Take I-95 to Clinton then take exit 138 towards Clinton. Turn right onto Hinkley Rd. drive 1.0 miles turn left onto Main St / ME 11/ME 100 drive 5.8 Miles. Turn right onto Troy Road, drive 4.5 Miles. Turn right on Garcelon, drive 1 miles to 119 Garcelon Rd.
