Please help us keep the trial moving by being ready for your runs and help when needed. **We thank everyone in advance and hope you have a great weekend!**

IMPORTANT NOTES

Schedule: Site will open at 8:00 a.m. Briefing at 8:45 and the 1st team on the line at **9:00 a.m.** The Course Marshall will be available to answer any questions during walk thrus. All doors and gates will be clearly marked.

- The run order and maps will be posted inside Little Paws and in the lobby of Big Paws.
- **Crating:** There will be plenty of crating in Little Paws.
- **MASKS:** All those who prefer to wear masks are welcome to do so.
If you have had COVID or have been exposed to COVID in the past 14 days, please follow the CDC Isolation & Exposure Guidelines: <https://www.cdc.gov/covid>

We appreciate your cooperation in protecting our Field Turf by adhering to the following rules:

- Chairs and tables must be placed on the hard floor perimeter of the ring.
- Do not drag any of the obstacles on the floor – they must be lifted to move them.
- Only soft-soled shoes are allowed. Your shoes must be clean and dry. During inclement weather, please change footwear before running dogs. Check your shoes each time you come in the building to be sure you did not step in a neglected poop!
- THE USE OF ANTI-SLIP SPRAY OR WAX IS STRICTLY PROHIBITED
- Make sure you walk your dog before each run.
- If you dog eliminates in the ring, gather them up immediately so they stay in one spot. Urine must be blotted immediately with microfiber towels that are located on the windowsill around the room as well as in the basket on the floor. DO NOT USE PAPER TOWELS ON THE TURF.
- There will be a **\$20 cash fee** for every dog elimination on the turf.
- **Parking:** If you are crating in Little Paws, please unload and park away from the buildings. Please leave parking spaces nearest the building for exhibitors working from their cars. Handicapped spaces are available on first come basis. **There is no overnight RV parking.**

The run order and maps will be posted in Little Paws and in the lobby of Big Paws.

The Gate Steward will invite you into the building. Please wait until you are asked to come in.

- **Scores** will be posted in Little Paws. Qualifying & placement ribbons will be self-serve in Little Paws.
- **Please let us know if you get a title so we can give you a rosette!**

DIRECTIONS:

Paws 'N' Effect, 36 Corporate Ridge, Hamden, CT 06514

From I-91: – Take exit 10 (Rt 40) to end. Right onto Rt 10 (Whitney Ave) approx 1 mi. to left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From Rt. 15: South: Exit 62 to Whitney Ave. north. Continue on Whitney Ave (Rt 10 North) for approximately 3 mile. Turn left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From Rt 15: North: Exit 60 (Dixwell Ave). Left at end of ramp – go to intersection with Rt 10 (Hamden Town Hall on left). Turn left onto Rt 10 (Whitney Ave north). Go 2.1 miles to Sherman Ave. Turn left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From I-84: Exit onto Rt 691, then 1st exit onto Rt. 10. Follow through Cheshire into Hamden and take right onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.
