Hello Exhibitors,

Please read your confirmation carefully to ensure that your dog is scheduled in the correct class, entered in the correct level and jumping the correct height.

Thank you for entering our CPE Trial hosted by Stockade Agility Located at Sugar Bush Farm. We have a total of 172 runs on Friday, 262 runs on Saturday and 251 runs on Sunday. We will move the trial along efficiently and smoothly to make sure everyone has a safe, successful and enjoyable time in the ring.

This will be a small trial so we need everyone's help to work and pitch in to move things along!

We still have runs available if you would like to add runs for your dog, enter another dog or knows a friend who still wants to enter. Please email me by 6pm on Monday 7/20 if you would like to add runs. There will be no day of show entry at this trial.

Please listen carefully to both the general briefing in the morning and the Judge's class briefings. Walk throughs will be timed at 5 minutes before each class. Please be ready when your class is called. If you have a scheduling conflict let us know as soon as possible so that we can accommodate your needs. No one will miss their run.

If you will be potentially running for a big title (C-ATCH, C-ATE, Points Title, etc), please let us know so we can help you celebrate!

DECLARED TRAINING IN THE RING WILL BE OFFERED AT THIS TRIAL:

We will offer declared training in the ring. The handler has the option if they want to use a toy or training aid at any time during their run, the handler must approach the Judge during Walkthrough or previously in that trial day for the Judge to approve the toy or training aid for use on the course.

- Handler must alert the Judge upon entry to the ring that the dog will be TIR. Handler is then allowed to have a reasonably sized silent toy/aid with them for use once their run has started (this toy must be approved by the Judge of record PRIOR to the start of the class to determine its eligibility, absolutely no food/scents/audible devices). The toy is NOT allowed to be used in either gate chute or prior to the previous dog leaving the ring. See the online rulebook or current member letter for additional rules. The following items are considered training in the ring (see Fix and Go):
- Violating the 4 paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games

SITE DETAILS:

There will be garbage receptacles for dog waste, cigarette butts, and any other garbage. Please bring water for your dogs.

COURSE MAPS: Will be posted on My Dog Entry the evening before the trial. No course maps will be emailed out.

Friday: Measuring 9:30AM; General Briefing at 9:45 AM, First Dog on the line 10:00 AM,

Saturday & Sunday: Measuring 7:30 AM; General Briefing at 7:45 AM First Dog on the line 8:00 AM

There will be NO measuring of dogs AFTER the Judges Briefing begins each day.

ALL DOGS WITHOUT A PERMANENT HEIGHT CARD MUST BE MEASURED before the Judges' Briefing in order to show that day – THERE WILL BE NO EXCEPTIONS.

MOVE-UPS - CLOSING DATE:

The deadline for contacting the secretary with move ups or corrections before the trial is the end of day on Monday, July 20th at 6pm. Any changes to entries made after that date will be subject to a \$10 service fee per change if I am able to fix it for you. **Once all of the paperwork done for the trial there will be NO changes made no matter who is at fault.**

DIRECTIONS TO SUGAR BUSH FARM

760 East Road, Stephentown, NY 12168

From the East: Take the Mass Pike to the end. Continue on I-90 to the next exit, B-3 in Canaan, NY. At the end of the ramp go right, 22 North. In New Lebanon, Route 20 and 22 run together for a short while. Make sure you stay on Route 22 by bearing left just before the boarded-up gas station on the left. Continue approximately 4 miles to the traffic light in Stephentown where Routes 22 and 43 intersect. Go straight to continue on 22 North. Follow Directions from the 22/43 Intersection below.

From the West: Take I-90 East to Exit 11E - Route 20 East. Continue on Route 20 East until it joins Route 22 North. Follow Directions from the 22/43 Intersection below.

From the North: From Hoosick Falls you will take Route 22 South. Go through the town of Berlin. Approximately 3 miles south of the Berlin Jr./Sr. High School on your left is Giles Road or County Route 33. Take that road, it takes a sharp right at a horse farm (you'll see tan buildings and split rail fencing on the right). You will go over a little bridge, you'll see farm buildings and straight ahead on the right you will see the training building - white domed roof with tan walls and windows. There is a driveway marked by two metal fence posts just before the building; follow that driveway to the ring and parking.

Directions from the 22/43 Intersection: Heading North on Route 22, you'll go up a hill where 22 becomes 2 lanes. It goes back down to one lane after you get to the top of the hill and you will pass a mobile home park on your right. Just after that there is a brown house with a big satellite dish. The road right next to that house is Giles Road or County Route 33. Take that road, it takes a sharp right at a horse farm (you'll see tan buildings and split rail fencing on the right). You will go over a little bridge, you'll see farm buildings and straight ahead on the right you will see the training building - white domed roof with tan walls and windows. There is a driveway marked by two metal fence posts just before the building; follow that driveway to the ring and parking.

If you do email me just an FYI, I will be camping in the Adirondacks with potentially limited internet/cell phone access Thursday -Sunday. I will be home Sunday evening and will return all emails received ASAP,
