**Times:** SCALE Training Center will open at 7:00am

- 🐾 Competitors set up (in cars) is from 7:00 am to 7:30 am. **Check in on the gate sheets posted.**
- 🐾 **Briefing** to explain "Round Robin" & course walk throughs at 7:45 am at building entrance.
- 🐾 **First dog on the line** when briefing, questions and course walk through are completed.

**VERY IMPORTANT - Groupme App: We use this app EXTENSIVELY during the trial to communicate. To join Groupme click on the QR Code**

- 🐾 We will give regular updates on when levels/classes will begin.
- 🐾 Please pay attention to what is going on – we will do our best to communicate with you, but it needs to be a two-way street.



**Parking:** Please Park in the lower parking lot.

**Crating:** will be from personal vehicles on both days.

**Pottying Dogs:** The potty area for dogs will be marked with signs, do not potty dogs on anything man-made or on landscape plants.

**Human Restrooms:** Enter the main doors and follow the **Blue** dots to the nearest restroom.

**Championship Awards:** Please contact our trial secretary, Lisa Newinski at lnewinski@gmail.com, if you might earn a Champion Title (Level 5 or C, SNITCH or SNITE). If you don't let us know, we might not have the right bling on hand!

**Results & Ribbons:** We will post results after completion of each event. Ribbons are self-serve at a designated table.

**Remember:** You must verify your results before you leave the premises each day. We CANNOT change results after the trial closes.

**Move-ups:** There will be move-ups **between** days only. All move-ups are due on Saturday before you leave the facility. **Move ups are NOT accepted via email.**

**Volunteers:** Please contact Marissa Andrews (missmandm4@gmail.com) if you can help. All volunteers get snacks and beverages. If you work two shifts, you get \$4 off a run in a future NSDS trial and you get an additional \$4 off for each shift above and beyond 2!

*\*The term “pm” is not literal. Depending on how the trial runs, lower level “pm” events may start before noon.*

**Round Robin Run Order:** We will be running two Judges at the same time, same level, different elements. Example: Saturday am, Alex will run Interiors at the same time as Juli runs Exteriors, always at the same level.

Within the Round Robin, if you are entered in both searches at the same level, proceed from one search to the next. Follow instructions on the gate sheets regarding which search you should attend first.

**Example:** I am running my dog in Level 1 Exteriors and Level 1 Interiors. Saturday morning, the run order says I start with Exterior. Right after the walk through, I proceed to Exteriors. When I complete that search, I go directly to the Interiors queue and run my Interiors search. After my Interior search, I am done for the “morning”.

**Health of Dogs and People:** Dogs should be healthy and up to date on vaccinations per your vet’s recommendations. **If YOU are sick, please stay home.**

**See Something? Say Something!** If you have concerns about the safety of a search, or a possible rules violation before, during or immediately after your run, please SPEAK UP so we can address your concern in a timely fashion. We can only fix a problem if it is raised at the trial... not on Facebook days after the event (BOO!). We want everyone to be safe, whether they have 2 or 4 legs.
