



Northern Border September 12-13 CPE Agility Trial

The building will open at 8 AM, and measuring will be from 8:30-8:45 AM, both days. First dog on the line at 9 AM both days. Our judge will be Jason Pierce.

There will be Day of Show entries (until we reach our maximum of 375 runs per day) at \$20 per run from 8:00 - 8:30 AM both days. Please bring a completed premium. We would appreciate a check or correct change. If you know someone coming for DOS please advise them.

Final move up is September 7. Move ups for Standard, Snooker, and Jumpers must be made before leaving the trial site.

The running order will be posted on MyDogEntry on Thursday September 10th. Due to DOS entries and conflicts for handlers with multiple dogs there may be changes in the running order. Please check your entry confirmation and posted running order for accuracy.

Course maps will be posted to MyDogEntry and will be released for viewing by 3:00 PM the day prior to each trial day. Course maps will NOT be emailed.

IMPORTANT NOTE: The IDS Championship (dock diving) will be happening this same weekend. But don't worry! We have a plan to make parking and accessing the building as easy as possible. There will be room for loading and unloading to make it easier for those crating in the building. Please review the map below.
