DAY OF SHOW ENTRIES: Entries submitted after closing on September 9th are \$20 per run. DOS Entries will be accepted at 7am each morning until 30 minutes prior to start or last class of the day. CPE number is required. If the limit is reached for any/all day(s) by the closing date, the club will contact CPE to have FULL posted to the CPE events page, for any day(s), is required of the club. The exhibitor must verify the limit has not yet been reached between the closing date and trial date if planning on attending. NOTICE TO EXHIBITORS

- *The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- *Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- *It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
- *Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- *Requests for refunds after closing will be considered by the GLOC board (less \$6 admin fee and \$1.80 CPE recording fee per run). A decision will be provided after the next GLOC board meeting (typically meets the first Thursday of the month).
