All workers will receive WAG Bucks (members may choose WAG Bucks or hours) for use toward future WAG trial entries, AKC, CPE, or UKI. Workers will also be offered lunch and beverages. Thank you for volunteering!!

Crating will be allowed in the blue matted ring and a protective mat **MUST** be put under all crates and chairs. Please potty dogs in the designated area at the REAR of the building and pick up after your dogs.

Doors will open at 7:00 a.m. You may enter the building through the front doors or the door at the back of the building which is closer to the crating area. There will be a loading/unloading zone near the back door.

Lunch will NOT be available for purchase on-site. WAG refrigerators are NOT available for public use, so plan on bringing your own cooler if you need to keep food cold. There are fast food restaurants in the area.

There will be a General Briefing in person. Please see the attached General Briefing document for additional details. We appreciate everyone's patience and cooperation.

Check-in and measuring will be from 7:30-8:00.

GENERAL BRIEFING: There WILL be a face-to-face briefing at the trial.

JUDGE'S CLASS BRIEFINGS: The judge's briefings for each class will be on each course map and there will be briefings for each class.

FOOD: Water and soda will be available for workers and for purchase. Lunch will be available for workers. WAG refrigerators are NOT for public use, so please bring coolers if you wish to keep things cold.

CRATING: There is plenty of indoor crating. Bring your own crates and chairs as WAG public crates and chairs will be limited.

WALK-THRUS: Time limit on walk-thrus will be 5 minutes for each jump height group. Levels 3/5/C may be broken into two groups: 4/8/12 and 16/20/24. Levels 1/2 will all walk together unless the number of handlers should require the group to be split. Walk-thrus for large classes, like FullHouse and Jackpot, will be split into smaller groups.

CHECK-IN: We will be using Real-Time Run Order, rather than paper gate sheets, for this trial. Please be sure to check your dog(s) in with the gate steward or online at My Dog Entry: <https://mydogentry.com/>

COURSE MAPS: Course maps will be posted the evening before each day on My Dog Entry <https://mydogentry.com/public/trials/966>. Full size course maps will be posted at the trial. It is suggested you take a photo of the course maps with your phone and move on. Please be respectful of others.

RUNNING ORDER: The running order will be posted on My Dog Entry <https://mydogentry.com/public/trials/966>. The running order is subject to change due to move-ups and DOS.

SEATING: Please bring your own chairs as WAG public chairs will be limited. There will be no seating or gathering on the black matting between the crating area (blue mat ring) and the show ring (turf ring). This space is for dogs and handlers that are entered in the class currently running. Seating is only allowed in the crating area. Please be respectful of others.

LINING UP FOR YOUR RUN: We will be utilizing chutes at the entrance and exit of the ring. The gate steward will direct you when to move into the chute and when to go in the ring. Please follow the gate steward's instructions. After your run, get your dog into the exit chute where you will find your leash. Please celebrate with your dog, leash up, and move out of the area as quickly as you can. To keep congestion to a minimum, please do not hang out in that area.

LEASHES: Handlers have the choice to put their leash in their pocket or safely loop them around their waist or neck. It does not have to be out of the dog's sight, however if the dog plays with it during a run it would be considered a toy. If you cannot carry the leash it should be dropped on the ground at the start line and the leash runner will pick it up and place it in the exit chute on the floor. Please get your dog into the chute as quickly as possible to leash up.

MEASURING: There WILL be official measuring at this trial. If your dog appears on the measuring sheet generated by CPE, your dog MUST be measured before you run or you must present an official height card from another venue. (See rulebook for specific details.)

RESULTS: Results and ribbon labels will be placed in binders on the ribbon table. There will be a binder for each class. It is suggested that you take a photo of your results with your phone and move on. Please be respectful of others. You can also log into your My Dog Entry account to see your personal results.

RIBBONS: Ribbons will be "self serve".

SPECIAL AWARDS:

- High in Trial for the weekend will be awarded after the last class on Sunday has been scored.
- Fastest 51 Snooker prizes will be awarded to the fastest 51 in both levels 1/2 and in levels 3/5C.
- "Perfect 10" medals will be awarded to all dogs receiving a qualifying score in all 10 runs for the weekend.
- "Polished Turd Award" or "What was that shit?!?!" awarded to a team chosen by the judge.

NQ RAFFLE: We will be holding an NQ raffle each day. Handlers will be responsible for putting their names in the bucket for their NQ runs. Drawings will be held each day after the last class is scored.

WORKER RAFFLE: We will be holding a worker raffle each day. Handlers will be given a raffle ticket for each class worked. Drawings will be held each day after the last class is completed.

2026 TOP TEN DOGS: Results from this trial will count toward the 2026 Top Ten Dogs competition. Results will be forwarded to Mary Lynn for tabulation.

Being respectful of others will ensure we all can have a safe and fun trial.
