From Cleveland: I 480 to Rt 14 SE for 43.9 miles. To Washingtonville, OH 44490. Turn Right on to Painters Path (next to bank building) and go South for 1,600 feet. Drive up the hill for front of building, do not drive behind the building.
From Akron: I 76 to Rt 14 SE, the follow above directions.
From the South: Rt 7 N to Rt 11 N (25.2 miles) to Rt 46. At exit ramp turn right on to Rt 46 (2.3 miles). At first traffic light turn right on Rt 14 W (4.1 miles). Turn left on to Painters Path (next to bank building) and go South for 1,600 feet. Drive up the hill for front of building, do not drive behind the building.
From I 80 Western PA: I 80 W into Ohio. Take Rt 11 S to SR 46, then follow the above directions.
